They will need to provide us the drawings for the electric and for the footer detail. They are working on those and they will be coming pretty soon, I spoke with the architect on Tuesday. Other than those construction issues the Building Department gives it a favorable recommendation. Mr. Kolick stated you are in position to act on this tonight, it is a Public Facility and will need to go to City Council. They have a Special Meeting on Tuesday so we can get this accomplished so everything can be approved and they can go forward and get this in before the new school year.
