The Planning Commission of the City of Strongsville met at the City Council Chambers located at 18688 Royalton Road, on *Thursday, March 7, 2024 at 5:45 p.m.*

The following was discussed:

SOUTHWEST GENEREAL HOSPICE PAVILION: Mrs. Daley stated the request is for a 18' x 32' gazebo to be located on a concrete pad, which will be located on the south side of the Hospice building. George had no issues with the request from any zoning aspects. From Engineering it is in approvable form. Mr. Hurst stated it meets the zoning and it is in the Public Facilities District so, it requires Planning Commission approval. The Building Department has no issues with this request.
