RESOLUTION NO. 2025 – <u>022</u>

A RESOLUTION AUTHORIZING THE MAYOR TO ADVERTISE A REQUEST FOR PROPOSALS FOR PROFESSIONAL REAL ESTATE AGENCY, MARKETING, AND ADVISORY SERVICES, IN CONNECTION WITH SALE OF APPROXIMATELY 87.5 ACRES OF CITY-OWNED INDUSTRIAL LAND FOR ECONOMIC DEVELOPMENT, AND DECLARING AN EMERGENCY.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

- **Section 1.** That the Mayor be and is hereby authorized to advertise a request for proposals for professional real estate agency, marketing, and advisory services in connection with sale of approximately 87.5 acres of City-owned industrial land for economic development purposes, and in accordance with the documents on file in the office of the Director of Economic Development, which are, in all respects, hereby approved.
- **Section 2.** That the funds for the purposes of this Resolution have been appropriated and shall be paid from the General Fund and/or the General Capital Improvement Fund.
- **Section 3.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council; and that all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.
- **Section 4.** That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the City, and for the further reason that it is immediately necessary to advertise a request for qualifications for professional real estate agency, marketing and advisory services for the sale of City-owned land, and to conserve public funds. Therefore, provided, this Resolution receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.

AN ORDINANCE REQUESTING PARTICIPATION IN OHIO DEPARTMENT OF ADMINISTRATIVE SERVICES CONTRACTS FOR THE PURCHASE OF SIX (6) 2025 DODGE DURANGO POLICE VEHICLES FOR USE BY THE POLICE DEPARTMENT OF THE CITY; AUTHORIZING THE MAYOR AND THE DIRECTOR OF FINANCE TO DO ALL THINGS NECESSARY TO ENTER INTO AN AGREEMENT IN CONNECTION THEREWITH, AND DECLARING AN EMERGENCY.

WHEREAS, Ohio Revised Code Section 5513.01(B) provides the opportunity for counties, townships and municipal corporations to participate in contracts of the Ohio Department of Administrative Services for the purchase of vehicles, machinery, materials, supplies or other articles; and

WHEREAS, this Council wishes to take advantage of that opportunity in connection with the purchase of six (6) 2025 Dodge Durango Police Vehicles from Greve Chrysler Jeep Dodge, all with certain options and appurtenances (Contract No. RSI024972, Index No. GDC050), for use by the Police Department.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

- **Section 1.** That the Mayor be and is hereby authorized and directed to request authority in the name of the City of Strongsville to participate in the Ohio Department of Administrative Services contracts for the purchase through **GREVE CHRYSLER JEEP DODGE** of four (4) 2025 Dodge Durango Police Vehicles in the amount of \$69,975.00 each, together with two (2) 2025 Dodge Durango Police Vehicles in the amount of \$70,730.00 each, which will be equipped as K9 vehicles, all with certain options and appurtenances, for a total amount not to exceed \$421,360.00, for use by the Police Department of the City, as indicated collectively on Exhibit A attached hereto and incorporated herein, which the Department has entered into pursuant to Revised Code Section 5513.01(B).
- **Section 2.** That the City of Strongsville hereby agrees to be bound by the terms and conditions prescribed by the Director of Administrative Services for such purchases and to directly pay the vendor, under each such contract of the Ohio Department of Administrative Services in which the City participates for items it receives pursuant to the contract.
- **Section 3.** That the Mayor and Director of Finance be and are hereby authorized to enter into and execute such agreements and documents as may be necessary to participate in the Ohio Department of Administrative Services Office of Procurement Services Program.
- **Section 4.** That the funds for the purposes of said contract have been appropriated and shall be paid from the Emergency Vehicle Fund.

Section 5. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council; and that all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 6. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare, and for the further reason that it is immediately necessary to participate in such program and purchase such vehicles in order to maintain continuity in the operation of the Police Department, to provide for the safety and welfare of the public, and conserve public funds. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise from and after the earliest period allowed by law.

ORDINANCE NO. 2025 - 029

AN ORDINANCE AMENDING SECTION 266.13(a) OF PART TWO-TITLE SIX OF CHAPTER 266 OF ADMINISTRATION CODE OF THE CODIFIED ORDINANCES STRONGSVILLE CONCERNING OF THE CITY RULES AND REGULATIONS, AND DEPARTMENTAL DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1. That Section 266.13(a) of Chapter 266 of Title Six of Part Two-Administration Code of the City of Strongsville be and is hereby amended to read in its entirety as follows:

266.13(a) RULES AND REGULATIONS.

- (a) Each department head may from time to time promulgate rules and regulations establishing departmental practices and procedures for and in furtherance of the employment provisions of this Chapter. Such rules and regulations shall be in full force and effect after approval of the Mayor and posting of a copy in the department in question for a period of ten days.
- (b) Violation by an employee of any rule or regulation adopted in accordance with this section shall be grounds for disciplinary action.
- (c) This section shall not be construed to limit or otherwise contravene disciplinary action for cause other than violation of a rule or regulation adopted hereunder.

(Ord. 2011-043. Passed 4-4-11.)

Section 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare of the City, and for the further reason that it is immediately necessary to properly provide for rules and regulations for each City department; and to conserve public funds. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.
