# SUMMARY OF CAUCUS DISCUSSION AND MINUTES OF THE STRONGSVILLE CITY COUNCIL REGULAR MEETING HELD ON, MONDAY, JUNE 6, 2022.

The Council of the City of Strongsville met in the Caucus Room at the Mike Kalinich Sr. City Council Chamber, 18688 Royalton Road, on **Monday, June 6, 2022 at 7:30 p.m.** 

**Present: Council Members:** Thomas M. Clark, James E. Carbone, Annmarie P. Roff, Joseph C. DeMio, Gordon C. Short, James A. Kaminski and Kelly A. Kosek. Also Present: Clerk of Council Aimee Pientka. **Administration:** Mayor Thomas P. Perciak, Law Director Neal Jamison and Finance Director Eric Dean.

Council President, James Carbone, called the caucus to order at 7:30 p.m.

Planning, Zoning & Engineering Committee: Chairman Kaminski advised Ordinance No. 2022-088 is to enter into an agreement with the Board of Park Commissioners of the Cleveland Metroparks to provide funding in connection with the Whitney Road covered bridge project. The funding is in the amount of \$50,000.00. Councilman Short asked if there is a starting date for this project. Mr. Jamison advised the rehab project cost is approximately \$350,000.00; and it's scheduled to begin next year around this time. Mayor Perciak advised it is hard to find engineers and others to work on a covered bridge project. Councilman Kaminski noted that this project also needs to include renovations for the safety of pedestrians and small children who walk over the bridge. There is a hazard of falling into the river if one is not careful. Mr. Jamison advised there will be a lane for pedestrians and bike users; and that Mr. Kaminski should reach out to the engineering department with his recommendation. Suspension and adoption was recommended for that legislation. Suspension and adoption was also recommended for Ordinance No. 2022-089; an ordinance accepting for dedication to public use certain lands within the Commerce Parkway subdivision.

Finance Committee: Chairwoman Kosek recommended suspension and adoption for Ordinance No. 2022-090; an appropriations ordinance for the annual expenses and other expenditures for the city. Ordinance No. 2022-091 is to amend the general salary ordinance in order to update the section relating to the compensation for attendance at a council meeting for any employee designated as "Acting Clerk of Council." Suspension and adoption was recommended for that legislation. Resolution Nos. 2022-092 and 2022-093 pertain to repealing previous Resolution Nos. 2022-077, 2022-078, 2022-086 and 2022-087; resolutions pertaining to submitting to the ballot for the November election a .4-Mill renewal ley for storm sewer and storm drainage construction and renovation; and a 1.5-Mill renewal levy for firefighter salaries and operating expenses of the Priem Road and Albion Road fire station, respectively. There was a language issue with the Board of Elections on the previous resolutions submitted; so these resolutions will amend the language; then be resubmitted to the Fiscal Officer to certify the total tax valuation generated for said levies. Suspension and adoption was recommended for those resolutions. Suspension and adoption was also recommended for Resolution No. 2022-094; a resolution adopting the alternative tax budget information for the city for Fiscal Year 2023.

<u>Public Service & Conservation Committee</u>: Chairman DeMio advised Ordinance No. 2022-095 is to enter into a contract with Buckeye Pumps, an authorized dealer for OTC Industrial Technologies Company, for the purchase and replacement of two sanitary sewer lift station pumps, together with repair kits, for various lift stations at the wastewater treatment plants. The contract is in a total amount not to exceed \$89,795.64. This is without public bidding so all 7 votes of Council are needed for this to pass. Mayor Perciak advised there will be future upgrades to these plants that will cost in the millions; and there will be a meeting on June 15<sup>th</sup> with MS Consultants to discuss this. Suspension and adoption was recommended for that legislation. Resolution Nos. 2022-096 and 2022-097 are granting permission to repurchase certificates for burial rights in the Strongsville Municipal Cemetery

(Lange and Kasper & Fiest, respectively). Suspension and adoption was recommended for both these resolutions.

Committee of the Whole: Mr. Carbone recommended suspension and adoption for Ordinance No. 2022-098; an ordinance amending Section 220.02(h) of Chapter 220 of the Codified Ordinances concerning the Clerk of Council and allowing the Council President to designate someone to serve in that capacity in the absence of the Clerk.

Ms. Kosek made a motion to adjourn into executive session for the purpose of discussing personnel matters pertaining to the employment a public employee in the Council office. It was seconded by Mr. DeMio to adjourn from open session into executive session [Article XI, Section 9, City Charter]. All members present voted aye and the motion carried. Council adjourned into executive session at 7:47 p.m. Also present from the Administration: Law Direct Neal Jamison. The executive session concluded at 8:03 p.m. and reconvened into open session.

# REPORTS OF COUNCIL COMMITTEES:

SCHOOL BOARD – Mr. Clark: Thank you President Carbone, there was a Strongsville City Schools Board meeting on Thursday, May 26<sup>th</sup>. This was also the retirement reception for several dedicated school employees that have wrapped up a tremendous career with Strongsville City Schools. Candidly, there was so much recognition of students and staff that evening that I could not possibly recap it all here; but I would encourage anyone that has not watched the online version to visit <a href="https://www.strongnet.org">www.strongnet.org</a> and specifically, the technology department's SCS-tv. There was a moment of silence for the Uvalde Texas School shooting. School Board President Richard Micko commented that our schools will look at what we can do better with respect to school safety. I want to comment on the partnership between our safety forces and our schools. As a resident and parent in our community, I am thankful for the school resource officers that we have and the desire from both sides to keep our schools and our community safe. Every single member of Council has children or grandchildren in our schools currently; or relatively recently had children in our school district. We all support continuously looking for ways to make and keep our kids and our community safe. Back to recognition, Strongsville City Schools was recognized for:

- Best Communities in music education for the 9<sup>th</sup> straight year.
- DECA (Distributive Education Clubs of America), part of the marketing education program, had 14 National Competition qualifiers. I personally competed in the same competition many, many years ago; and I'm confident that the experience and the opportunities they've had will help them and be successful in their aspirations and business. I am excited to see what the future holds, not only for those 14, but all 91 Strongsville DECA students at Strongsville City Schools.
- There was 7 National Merit Scholarship commended students
- 4 National Merit Scholarship finalists
- 1 National Merit Scholarship finalist, the only name I'm going to call out today, Zoe Zylstra top 1% nationally.
- Strongsville High School Leukemia & Lymphoma Student of the Year was recognized.
- 8 staff members joined forces to bring a unified sports team to Strongsville High School, including 20 athletes and 20 partners; and making Strongsville High School a host school. Unified sports is part of the Special Olympics and is dedicated to promoting social inclusion through shared sports training and competition experiences.

Treasurer, George Anagnostou, took us through the 5-year financial forecast; which was approved and adopted by the board. There was a lot of human resources related content in the meeting, as you might expect, with the end of a school year, retirements and contracts for the next year needing approval. I do want to highlight one in particular. Strongsville City Schools board approved the adding of an assistant athletic director, and our own, Jason Keppler from the Strongsville Recreation Center, was announced as the new assistant athletic director. Jason has been a tremendous asset to the Strongsville community for about 15 years. I have interacted with him personally numerous times as I have coached many sports and I think he is one of the best around. I am sad to see him moving on from our rec, but delighted that he is remaining in our Strongsville community. I cannot imagine a better selection for the position. Jason has impacted so many families in our community. Think about this, 15 years ago he was offering Tee Ball in our community through his work in the sports programs there; and last week, those kids that were in our Tee Ball program, many of which competed in the regional baseball Ohio High School Athletic Association tournament. Lastly, I want to share some athletic highlights that happened. As I mentioned, the baseball team in the regional finals, before ending their season; and the track team placing multiple events at the State track meet. That concludes, pending any questions, the school board report.

#### **BUILDING AND UTILITIES - Mr. Clark:**

SOUTHWEST GENERAL HEALTH SYSTEM - Mr. Short: Thank you Mr. Carbone, for Southwest and a COVID-19 update, the number of people of hospitalized with COVID-19 has continued to increase with the latest kind of variant going around. Southwest is now averaging about 13 patients per day over the past two weeks, with a high of 17; however, the number of patients requiring critical care has been low. COVID-19 testing at the system is also increasing; although again, patients requiring an extended hospital stay to recover from COVID-19 remains low. The system continues to have ample supplies of PPE equipment on hand and are able to replenish those items being used on a timely basis. They did recognize this past month "National Nurses Week" and "National Hospital Week," celebrating and recognizing their employees. Through the labor shortage though, Southwest has done a good job of continuing to engage employees and keeping them on staff and doing unique employment and employee focused programs; which yields benefits to the system as hiring has improved and the vacancy rate, in terms of needed FTE's, has decreased slightly at the system. As you know, healthcare is facing the same type of labor shortage like we have seen across most industries in the country right now. On some quick other notes for capital improvements; again, the system has committed about \$7.2 million of capital for investment into the organization so far this year, including projects at the surgery center, new orthopedic surgery equipment, a new CT scanner at the hospital, as well as replacing the surgical (unintelligible). Construction is nearly complete for the expansion and renovation of the Cosgrove Maternity Center. The work there is expected to be completed this month. They are now working with University Hospitals to set up a new Level 2 neonatal special care nursery; and expect to have the certification for that, by the Ohio Department of Health, this month as well. That concludes my report on Southwest but I will happily take any questions

**ECONOMIC DEVELOPMENT – Mr. Short:** I spoke with Mr. Painter today. We may try to have a meeting here before July 1<sup>st</sup>. If not, we'll schedule that for later in July, after I return from a little family vacation. That concludes my report.

Mayor Perciak – Don't forget the 14th.

Mr. Short – Yes, Tuesday the 14<sup>th</sup> our own Brent Painter will be speaking at The Chamber luncheon at the rec center. I believe that doors open at 11:30 a.m.; and lunch and the program begin at noon, if I remember correctly.

Mayor Perciak – Right, and again, we're asking as many of you to be present as you can. We are welcoming all the new business men and women from all of our business parks at this event. There's going to be a video on each and every one of them. Tom Clark is going to speak a little bit with his knowledge of what it takes to keep people employed. We have a female business. We have an African-American business; and we have all the new ones. We covered the spectrum pretty well; and these are all new businesses that have located in our parks, including the business that we brought in from China and the business we brought in from Germany. What we're trying to get across to everybody is we are a welcoming community and we value who they are in our community. We need to understand something, all of us, even though it is called the Strongsville Business and Technology parks, in today's day and age with technology being what it is; all of you know you can work from different places with the proper IT system. What we need...I'm looking for words Tom...

Mr. Clark – You're doing great Mr. Mayor.

#### **ECONOMIC DEVELOPMENT – Mr. Short (cont'd):**

Mayor Perciak – What we need though is people who come into work everyday in our parks and manufacture. Brent Painter went and spent most of Friday afternoon at Swagelok in Solon just to get a better feel for that. When their President was here a couple of weeks ago, we met with him, they want a bigger footprint here too. I asked him, "Would you please help us with our fireworks?" He wrote a check for \$6,000.00. These are the types of relationships that we want to encourage; but what we want to do is actually listen to the Presidents of these major companies, while looking to bring more people in here and what their issues are in putting people in these manufacturing jobs; because this is what is going to pay our bills in the future. For the first time ever, Eric will tell you, we actually had income tax receipts from Progressive in Mayfield Heights. How did that happen? They're working here; and it's the same thing, the people who actually were in the IT or connected to it an IT company, they're working elsewhere and that community is now collecting that income tax. For us, this is very important. This is a new movement on our part to make these people feel welcomed here and to make these people feel wanted and to expand their business and network with other businesses so they can come here. The is a (unintelligible). This is our future. Please don't take this lightly. This is important.

Mr. Short - Thank you Mr. Mayor, any other questions or comments?

Mr. Clark – Just a comment Mr. Mayor, when you talk about inviting the business people in, the business leaders, the business ladies and the business gentlemen, I read an announcement last week that a city was adding 2 facilities from a major Ohio employer. I remember attending a similar event to what your describing 15 years ago when we were talking about an expansion. We are looking at this for how can it benefit now; but this is 15 years later. This announcement that I read last week is the second one for that city; and it all began from an event 15 years ago. We're helping improve and grow our community and the business community and the partnership and there will be benefits this year and you talk about all these they're adding; but the long-term benefits that start from them needing each other and them coming and seeing and us listening to them is huge.

Mayor Perciak – One more thing Tom, what we're discovering at some of these things is sometimes these businesses now are actually acquiring some of their material and things they need from a business right here in Strongsville; so that is just huge.

PUBLIC SERVICE AND CONSERVATION – Mr. DeMio: Thank you, I appreciate it. On page 3, Ordinance No. 2022-095 and Resolution Nos. 2022-096 and 2022-097 – the bottom 2 are repurchases of burial rights, that's pretty simple. The other one is, to make a long story short, Ordinance No. 2022-095 is to make sure our wastewater gets taken care of properly; and it's an emergency to do it. We had a breakdown; so we need all 7 to pass it. I don't want to go into it other than I'm glad this Council is proactive and the administration and the law department notifies us this quickly because there were times it didn't happen quite that quick and we paid the price. We appreciate it, especially Ward 1, part of Ward 1, and part of Ward 3 I believe, right Mayor, is that correct?

Mayor Perciak - Yes.

Mr. DeMio - I appreciate it, is there any comments at all on mine? Okay, we're good.

Mr. Carbone – Thank you Mr. DeMio.

FINANCE - Ms. Kosek: Yes thank you, we have two ordinances and 3 resolutions on tonight's agenda. The first is Ordinance No. 2022-090. This is an ordinance to make appropriations based on our annual expenses and expenditures...some changes. We all received a memo from the finance department. There are 13 items that are changing; and some of these changes really to STEP services, some are RITA retainer fee accounts' issues; so I ask that we suspend and adopt this. We also have Ordinance No. 2022-091 which is a change to who can fill in when our clerk is unavailable at our Council meetings - changing that ordinance to allow whomever is sitting in for Ms. Pientka to be paid for their work. Resolution Nos. 2022-092 and 2022-093 are repeals of the resolutions that we previously passed regarding the renewal levy for the sewers and the renewal levy for the Ward 3 fire station. There was a little bit of a hiccup with the Board of Elections and the language that they wanted to have appear in the "Whereas" clause, correct Neal? They wanted to say exactly how long those renewals would be for; so we need to redo those. If we pass these tonight we would be repealing Resolution Nos. 2022-077, 2022-086 and 2022-078 and 2022-087 so that we can get these back down to the county so that they can make it on to the ballot. We have plenty of time because we were ahead of the game. Resolution No. 2022-094 is an alternate tax budget which is pretty perfunctory. I think all of these are suspend and adopt. If anybody has any questions I can answer them or our finance director is available also. That's all that I have for this meeting, thanks Jim.

**PLANNING, ZONING AND ENGINEERING – Mr. Kaminski:** Yes, Planning, Zoning & Engineering has two ordinances. Ordinance No. 2022-088 authorizes the Mayor to enter into a project development agreement with the Cleveland Metroparks to provide funding in connection with the Whitney Road covered bridge. That work will not begin until next summer at the earliest. Also, Ordinance No. 2022-089, an ordinance accepting for dedication public use of certain lands within the Commerce Parkway subdivision. The recommendation is suspension and adoption. That concludes my report.

#### PUBLIC SAFETY AND HEALTH – Mr. Kaminski:

**RECREATION AND COMMUNITY SERVICES – Ms. Roff:** I do not have anything tonight but I will happily take any questions. I do have an email out to Mr. Bogre at the rec looking for a date for the movie night. I have offers from a couple of the businesses here to cover the costs for that; so I'm just waiting for him to get back to me if you see him around Mayor.

Mayor Perciak – He's finishing up helping us get stuff going for the 4<sup>th</sup> of July and I'm sure he's talking to the same vendors.

Ms. Roff – Yes, I would just like to get some of the food trucks and stuff for a date because I know we struggled with that a little bit before and I thought it would look nicer if we have it...

Mayor Perciak – And continuing to struggle to get them.

Ms. Kosek – Are you thinking about the possibility of having it over here where we're going to have the new playground and splash pad, to kind of bring people closer to the rec; or are you thinking of having it at the same location?

Ms. Roff – That's what I mentioned to him, to have it over this way.

Mayor Perciak – As long as the 2 chiefs approve it.

#### RECREATION AND COMMUNITY SERVICES - Ms. Roff (cont'd):

Ms. Roff – That way, we can get some of the food trucks kind of set it up in the looks of how it will look when the center of town is done there. Also, I thought we could bring a couple of those bigger signs and some of the literature there for people to look at and get a little bit more public involvement there...donations and stuff like that. If you see him around, I just have some dates that look good for him

Mr. Carbone – Very, good, thank you for getting a jump start on that because the summer is going to go quickly.

## **COMMUNICATIONS AND TECHNOLOGY – Mr. Carbone:**
