SFES transports primarily to the main campus of Southwest General Health Center, but also to Southwest-Brunswick ER; Cleveland Clinic Main Campus, Brunswick ER, Fairview, Medina, ; University Hospitals Main Campus & Parma Medical Center; MetroHealth Medical Center Main Campus & Parma ER. As new options, UH-Broadview Hts. and MetroHealth-Brecksville are now available to receive patients. The Department transports approximately 90% of its patients to either SWGHC Main or SWGHC Brunswick Emergency Department.

The most frequent reasons for transport are Chest Pain, Difficulty Breathing, Altered Level of Consciousness, Diabetic Emergencies, and Stroke.
