**A RESOLUTION GRANTING PERMISSION TO
TRANSFER CERTAIN CERTIFICATES FOR
BURIAL RIGHTS IN THE STRONGSVILLE
MUNICIPAL CEMETERY.**

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF STRONGSVILLE,
COUNTY OF CUYAHOGA, AND STATE OF OHIO:

Section 1. That pursuant to Codified Ordinance Section 1060.09, and consistent with documentation presented to the City, Council hereby authorizes the Sexton to transfer the certificate for burial rights in the Strongsville Municipal Cemetery for Grave B, in Lot 105, of Section F, from Dwight Baker & Diane Baker, husband and wife, to Gary Stroemple & Barbara Stroemple, husband and wife; and in addition, the certificate for burial rights for Grave H, in Lot 128, of Section F, from Dwight Baker & Diane Baker, husband and wife, to Gregory Stroemple & Deborah Stroemple, husband and wife; and further waives the City's right to repurchase such lots.

Section 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council; and that all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 3. That this Resolution shall take effect and be in force immediately upon its passage and approval by the Mayor.
