SUMMARY OF CAUCUS DISCUSSION AND MINUTES OF THE STRONGSVILLE CITY COUNCIL REGULAR MEETING HELD ON, MONDAY OCTOBER 1, 2018.

The Council of the City of Strongsville met in the Caucus Room at the Mike Kalinich Sr. City Council Chamber, 18688 Royalton Road, on *Monday, October 1, 2018 at 7:30 p.m.*

Council President DeMio called the caucus to order at 7:30 p.m.

The following Council Committees met to review legislation on the agenda:

Committee of the Whole: Mr. DeMio recommended suspension and adoption for Ordinance No. 2018-143; an ordinance authorizing the sale at public auction certain obsolete and surplus vehicles in the police department and recreation and senior services department no longer needed. Ordinance Nos. 2018-144 and 2018-145 are TIF ordinances declaring improvements to certain properties to be a public improvement. The TIF properties are for Brighton Best and Cane's & Chase respectively. The recommendation for both these ordinances was to place them on first reading. Mr. John Veres, the city's TIF coordinator, was present and provided council an outline of what a TIF is, what they can be used for, and the two TIFs mentioned above. Mr. Painter added that the money collected by these TIFs goes to the city instead of to the county. The money generated by these can be used for infrastructure improvements such as the traffic signalization of the city.

Mr. Carbone scheduled a finance committee meeting for Monday, October 29, 2018 at 4:30 p.m. in the mayor's conference room.

Mr. Schonhut advised of the upcoming county master plan meeting scheduled for Tuesday, October 23, 2018 at the recreation department's event center.

Mr. DeMio – advised council will be most likely be voting on Ordinance No. 2018-105, the Circle K rezoning ordinance, at the October 15, 2018 council meeting.

Council President DeMio called the meeting to order at 8:00 p.m. All joined in the Pledge of Allegiance to the Flag.

Administration of Ceremonial Oath of Office to newly-appointed Firefighter/Paramedic David R. Javor.

Mayor Perciak – Yes, I'd like to administer two Ceremonial Oaths of Office to firefighter/paramedic Vue and firefighter/paramedic Javor.

Chief Draves – Thank you mayor, we do have two firefighters to swear in tonight. The first one is David Javor. David Javor was born and raised in Seven Hills, OH. Dave graduated from Holy Name High School in 2013. After high school, Dave attended Tri-C for his firefighter and EMT certifications. Dave then attended paramedic school at UH Parma Health Education Center and graduated in 2016. David comes to the Strongsville Fire Department with previous experience from Brooklyn, Independence, and Broadview Hts. Fire Departments. David is joined tonight by his parents, Vicki and Dave, his sister Andrea, his girlfriend Alyssa, and many other family members and friends.

Alain became certified as a Paramedic in 2015 and as a firefighter in May 2016. Alain comes to Strongsville Fire and Emergency Services with experience from the Fairlawn, Copley, Hartville, and Lakemore Fire Departments. Alain is joined tonight by family members and fellow firefighters.

Mr. DeMio – Thank you all very much for coming. Men and women of the fire department thank you so much for all you do and I'm very proud to be a resident of this town. So thank you and congratulations and welcome to the family, both of you, thank you.

REPORTS OF COUNCIL COMMITTEES:

Mr. DeMio – I just want to remind everyone that our master plan meeting is open to the public which will be October 23rd at 7:00 p.m. right around the corner at what we call our rec center; for those of you that are interested. I just want to make sure that's officially made in the minutes here at our council meeting.

SCHOOL BOARD – Mr. Carbone: Yes, at the last school board meeting, permission was granted to the Strongsville High School boys' and girls' cross country teams to travel to Rochester, NY to participate in the McQuaid Invitational. Also, permission was granted to the Strongsville High School German Club to travel to Austria, Switzerland and Germany. Then, this week and next week we have parent conferences all week; so make sure if you have a son or daughter in the schools you already schedule that. If not, please call and schedule that. Lastly, this week, Thursday, is typically the school board meeting. Because of the Taste of Strongsville, they have moved that to Wednesday evening. Wednesday evening they are going to dedicate that time to talk about the State Report Card which I was very impressed and pleased with the progress that our district made. A shout out to Cameron Ryba, his team, all the teachers, all the kids and all the families. It's truly a team effort. I will talk about that State Report Card at our next council meeting. SOUTHWEST GENERAL HEALTH SYSTEM – Mr. Short: Thank you Mr. DeMio, the board met last Wednesday. Again, Southwest General continues to have a great year both financially and in terms of quality and safety measures; patient volumes are up. The capital budget, they are spending about \$16.5 million this year in capital improvements to various units at the hospital and also on equipment, especially ultra sounds and surgery equipment. The one thing that if people are interested, this Friday, October 5th, the Lifeworks of Southwest General will host the Ohio Flags of Honor Memorial which is a memorial that travels through the State of Ohio to help facilitate fellowship for the families, friends and communities who want to pay tribute to Ohio's 299 fallen soldiers that have fallen over the past decade in Afghanistan, Iraq, and other areas of the world. They're hoping to raise public awareness to support Ohio's returning veterans as well. That will be this Friday, October 5th at Lifeworks at Southwest General. Again, I think it's key that we have such a great asset in the community. If you have any questions; if not, I will close my report.

BUILDING AND UTILITIES – Mr. Daymut:

Mr. DeMio – Mr. Daymut is unavailable today, so Tony, other than there is no objection further on down the agenda, any updates you want to give this council in his absence?

Mr. Biondillo - No.

Mr. DeMio – Okay, I just wanted to make sure that is clear for the record. When I said the objection, it has to do with a liquor permit that we will talk about later down the agenda.

COMMUNICATIONS AND TECHNOLOGY – Ms. Kosek: Thank you, we do not have any ordinances or resolutions on the agenda but if anyone has any questions I'll be happy to answer them.

ECONOMIC DEVELOPMENT – Mr. Daymut:

Mr. DeMio – I'm going to turn that over to the mayor. I know with Economic Development he always has something important to point out. Mayor, if you don't mind, I know Mike would be honored if you spoke on his behalf.

Mayor Perciak — Thank you Mr. President and good evening everyone. We had a very successful economic development breakfast on Friday. We were fortunate enough to have Bernie Kosar #19 of the Cleveland Browns to be our guest speaker on Friday to a full house. It truly was, again, a wonderful day here in our community when all of our business men and women, are small business men and women, were able to gather under one area and network and come and listen to Bernie and his 308 consecutive passes without an interception. He did not talk about the 309th one that...and then what's important, what's really coming down here, again, another step to help our small businesses in our community is our Business Expo which will take place on Thursday, November 1st at our recreation center. As of now, we are about 50% sold out. Again, we always, always, take our own business men into consideration first. After a certain point, some of the smaller businesses from the surrounding communities wish to participate and we allow them to participate. This is a free event for anyone who wants to attend. For any of the participants in the Business Expo, the fee is \$100. For the amount of advertising they receive and the ability to cross-sell their product to so many other people that attend, it's truly quite a coup for them. Plus not to mention, all the free advertising that they get. Again, that is Thursday, November 1st and that starts at 5:00 p.m. Thank you Mr. President.

Mr. DeMio – Mayor, I'm putting you on the spot, is there anyone that wants to ask the mayor any questions?

REPORTS OF COUNCIL COMMITTEES (cont'd):

PLANNING, ZONING AND ENGINEERING – Mr. Schonhut: Thank you Mr. DeMio, we have nothing on the agenda under that committee tonight; however, we do have somebody special that is near and dear to all of our hearts, tuning in tonight. That is our Assistant Council Clerk, Tiffany. Tiffany's mom unfortunately lost her battle with pancreatic cancer last week after a long hard fought battle. I think we were all there encourage Tiffany over the last year or so that has been going on. Tiffany's mom Carol is in a better place now. We just want to offer words of encouragement to Tiffany and just take a brief moment to recognize her mother if everybody would please.

A moment of silence was given.

Mr. Schonhut - Thank you and that that's all I have Mr. DeMio.

Mr. DeMio – Thank you so much, Tiffany is a great lady and her mother was awesome. Anyone that met her, she had her open house, knows that about Tiffany. That's Aimee's right hand lady. Tiffany actually came to work to make sure we were okay. That's what kind of lady Tiffany is; so if you don't know her, you know her a little bit now. She is a great person and her mother must have been one heck of a mom because she made a great daughter.

PUBLIC SAFETY AND HEALTH – Mr. Short: Thank you Mr. DeMio, we have no ordinances or resolutions on tonight's agenda but I will happily take any questions.

PUBLIC SERVICE AND CONSERVATION – **Ms. Roff**: I do not have anything for either committee but will take any questions. If Joe or Bryan has any updates, I know they finished the parking lot over at the playground, am I correct?

Mr. Bogre - Correct, the parking lot is all done.

Mr. DeMio - On which playground again?

Mr. Bogre - Surrarrer Park.

Ms. Roff - That's it.

RECREATION AND COMMUNITY SERVICES - Ms. Roff

COMMITTEE OF THE WHOLE — Mr. DeMio: It happens to have all the ordinances tonight. Ordinance No. 2018-143 will be suspension and adoption. That means we will be voting on that one tonight; for surplus vehicles and the city goes out and we auction them off or sell them off I should say; and we'll be voting on that. The next two ordinances will be voted on November 5th, first Monday in November. That the tax incentive program. I won't go into a long, boring story because you would all fall asleep and wonder why I talked so long. I will close the committee. I do want to say one...! mentioned the master plan. It's funny that Matt mentioned about cancer so I'm wearing pink tonight and the reason I'm doing that because it's Cancer Awareness. My mother, unfortunately, was a victim of breast cancer and so many of us have family members and friends. This is in honor of my mother so I hope when you look at me a little bit, you'll think of someone in your family or friends that has gone through that. It is a very respectful group of people here and we all try to do something a little different and this is my thing to my mother God Bless her. I think if you all knew her you would have liked her. I'll close that.

REPORTS AND COMMUNICATIONS FROM THE MAYOR, DIRECTORS OF DEPARTMENTS AND OTHER OFFICERS:

MAYOR PERCIAK:

(No report)

FINANCE DEPARTMENT – Mr. Dubovec: Thank you Mr. President, funds will be made available for all ordinances and resolutions on this evening's agenda requiring certification of funding. That ends my report, thank you.

LAW DEPARTMENT - Mr. Jamison: Thank you Mr. Chairman, I thought I would take the time in my report tonight to address why a lot of people are here tonight, in regards to the pet store in the mall. I would just like to point out for the folks that are in attendance that back in 2016, the Ohio Legislature passed Senate Bill 331 which basically took away the right of the cities to regulate pet stores in the State of Ohio. The State pre-empted that regulation and took it over. Enacting that Senate Bill 331, part of it was Section 956.23 of the Ohio Revised Code. I think it's helpful to read that for the folks here tonight because I think part of the reason they are coming is not only to illustrate their concerns about what is going on, but also for this council to pass the appropriate legislation. Once I read this, I think you'll have a better understanding of their power, or lack thereof to do that. Section 956.23 of the Ohio Revised Code says, "The regulation of pet stores is a matter of general state-wide interest that requires state-wide regulation. Sections 956.181 to 956.23 of the Revised Code, and Section 956.99 of the Revised Code constitute a comprehensive plan with respect to all aspects of the regulation of pet stores. Accordingly, it is the intent of the General Assembly to preempt any local ordinance, resolution or other law adopted to regulate the sale, delivery, barter, auction, broker or transfer of a dog to a person from a pet store." That was passed in December, 2016 and became effective on March 21, 2017. What that means in regular language is that the Ohio Legislature about a year and a half ago decided to take over the regulation of pet stores in the State of Ohio. They took that right or ability of each community, if they so desire, to do that; so that if your concern is that the regulations in place need to be updated or refined, that discussion needs to be with the Ohio Legislature down in Columbus with either your representative for the State of Ohio or your State Senator. This council, this mayor, doesn't have the ability to do that. That is something that the State took that right about a year and a half ago and are actually active in going forward with that. That being said, we take this seriously. In the last year, our animal control officer has been to the store in question 21 times. In those 21 times, he has not found any violation pursuant to what he can do. On top of that, the County Health Department has been out there and they have found no violations as well. We take it serious to the extent that every time a complaint is made we look into it. We don't overlook it because we take this seriously. I know a lot of you feel passionate, but the real place to express that is down in Columbus because they are the ones who preempted and took this over and regulate these stores at the present time, as well as the puppy mills and things that supply those animals to these stores. We understand your passion and welcome it, but I would say that it needs to go down to the legislators in Columbus. I see somebody raising their hand; what will happen is at your discretion, you have the right to come up in audience participation. You get five minutes; it's not to have a dialogue with anybody up here, it's to express whatever you want to say. Our rules do not allow back and forth, it's just for you to express your opinion. You don't have to come up if you don't want. Be respectful of everybody who is here and we'll give you five minutes for each person and then go forward from there. All ordinances and resolutions are in proper legal form for tonight's meeting. That concludes my report.

AUDIENCE PARTICIPATION:

Mr. DeMio – Audience participation is going to begin. We did have one person sign in. I know some people thing signing in just means you're here. If this person would like to come up, they are the first one. After that, I would ask that folks would be respectful; one at a time. The five minute rule, we do that out of respect of all the business we have to do. We'll give you a little notice ahead of time and we will apologize now if we have to cut you off. The first person that signed in was Kerry Stack. Just a couple of other things; if Kerry or anyone else is coming up here, even though it is a common name, we ask you to spell your first and last name. We also need your address; and other than that, you'll start. Kerry, if you could come on up, that would be great.

Kerry Stack, 30401 Oakwood Circle, North Olmsted, OH: Good evening. I'm Kerry Stack. K-E-R-R-Y. Last name Stack. S-T-A-C-K. We're going to split five minutes; which I think you guys will appreciate...

Mr. DeMio - Okay, just need your address too.

Ms. Stack - 30401 Oakwood Circle, North Olmsted, Ohio.

Kaylyn Parrinello, 14919 Hummel Road, Brookpark, OH: Hi, I'm Kaylyn Parrinello. It's a long one. K-A-Y-L-Y-N, first name. Last name P-A-R-R-I-N-E-L-L-O. I'm at 14919 Hummel Road, Brookpark, Ohio.

Mr. DeMio - Okay.

Ms. Stack – What I'd like to address is I do truly thank you, Mr. Jamison, for taking us seriously. And I do understand that this does need to be taken up in Columbus; that you're hands are kind of tied as it comes through the State; however, you have mentioned that in past year, Mr. Collin's establishment has been investigated, oh, I believe you said 21 times. The laws have since changed as of three days ago. That is why we are here today. As of just a couple days ago, effective immediately, HB 506; prior to purchasing a dog, broker; which would be Pick of the Litter, Tom Collins, must request breeder signed documents stating compliance with standards of care established. If breeder doesn't supply documentation, broker shall not purchase dog. Documentation, available for inspection during store hours. I have not seen any of those kind of documentation in the last three days. I have asked numerous people to go in there. Nothing has been supplied. Other things that have changed within the last three days; now, these are issues that have a little bit more time to comply with; but, I want to give you a visual. For those of us who don't understand what we're dealing with here.

Mr. DeMio – Can you turn it so we can see it...?

Ms. Stack - HB 506...

Mr. DeMio - Thank you.

Ms. Stack – Cage space; six inches higher than the tallest dog's head. These are all shots, from Pick of the Litter. Starting, the oldest one is from 2015. The newest one is from a couple days ago. Six inches higher than the tallest dog's head. Floor space length of dog, tip to tail plus nine inches. In other words, how many square feet are these dogs allowed to have, squared, times two. If you want me to do the math, I didn't do it. My husband did. That would be 15.12 square feet for this dog. That can't even turn around. Okay? Now, I did not need to be told that my children need to have a play space larger than a playpen. I didn't need to have resolutions put in place by Columbus to tell me that. I don't need the State to tell me that; because I know what animal abuse is and we're looking at it. There is no space for these dogs to turn around. Exercise...

Ms. Stack (cont'd) - ...this is also part of HB 506 as of a couple days ago. Daily exercise of at least 30 minutes. Given the opportunity for mental stimulation and socialization and run at full stride during daylight hours. I have spoken with some previous employees of Pick of the Litter and things I have been getting are not good at all. According to this, Tom did not like the dogs to run around. They were kept mostly in the cages at all times. He did not allow the volunteers, he's calling them volunteers, to take the dogs out to play. Umm, pretty much, dogs come in. They stay in the same area. They never leave. That is not part of any oversight from the State. These kinds of things can be seen on a local level. I ask you guys to investigate again. I ask you guys to no longer allow any kind of sales from puppy brokers in your city. It's been done in other cities who are mandated by their own States. California, for example, is starting to get rid of all puppy brokers, puppy mills. We have the worst record in all of the States. Let's change that.

(Applause)

Mr. DeMio -- Yes, so I'm going to stop...because you only had a minute left. Do you want your minute or...because I'm going to start a new clock for this young lady...

Ms. Parrinello – Umm, you can just...

Mr. DeMio – It's up to the lady that was just...right behind you.

Ms. Stack - Do as you wish.

Mr. DeMio - Okay.

Ms. Parrinello – Umm, yes I can start. It might go little over a minute...

Mr. DeMio – We're starting a new clock. Go right ahead.

Ms. Parrinello - Okay. My issue is a little bit different than Kerry's. I agree that I think that the law should change at a State level. I agree that; but, I also agree that there are some things that right now we can't change. The issue, my biggest issue is, I did... I did adopt a dog from here against my better judgement. I know better and I shouldn't have; but, it got the better of me because I saw the condition that she was in and I was told, when I had adopted her, that she was four months old and she had not one tooth in her mouth. Having vet tech background, I knew that this dog was no older than six, maybe eight weeks old. I do know that in the State of Ohio it's illegal to sell any puppy under eight weeks of age. When I did adopt her, I took her directly from there to my family vet. I had her looked over and I have, in my records that my family vet said the exact same thing. That this dog is six maybe eight weeks today. So, the records that I have from Pick of the Litter for this dog are, some of the vaccine records written in. Working in a vet clinic myself, you take the lot number sticker off the vile and you put it on the record for...if there's any recall or if there is any issue. Three of these are handwritten in. There's no lot numbers. These would have...the dates that are on here would have been before this puppy was born. This is just a blatant falsified record of my puppy. She...I adopted her on July 14th and let's say she was eight weeks old at that point, her birthday on this record is March 21st. This dog...if they had this dog and we're able to vaccinate her, even with the first, actual sticker on here of May 20th, she won't have been eight weeks old. Not even old enough to get a vaccine, let alone be in a cage to be sold to anybody. That was my big issue. You know, I know that we've said before, we haven't found any violations. They're not doing anything, technically against the law; but, to me, that's a huge issue. If we have puppies that have been in this cage, away from their mother for, let's say that this says she was in their care for a month. So, four weeks, she was than two weeks when they got her? That doesn't make sense to me.

Ms. Parrinello (cont'd) - When I bought her...when I took home, I was told to give her Fruit Loops on top of her dry food because she was hypoglycemic. So really, we're putting, like crumpled up Fruit Loops on top of her pup chow and they said, "Yea, it just...make sure that she doesn't...she gets a little groggy. She might go in and out of consciousness. She's has a little bit of a blood sugar problem." Well, also coming from a vet tech background, that does happen when you take a dog away from their mother too early and they're not getting the nutrients they need from the milk. If you have to do that you supplement with some kind of simple syrup like a Karo syrup, not Fruit Loops. That's going to cause trouble in the long run. I have had quite a bit of trouble with her. Allergies and things of that nature, just...again, probably because her immune system didn't get to be fully developed; but, that was...I just wanted to bring that to light that this record that I have, this is 100 percent falsified. There is no way that this dog was born in March.

Mr. DeMio - Do you have a copy of that?

Ms. Parrinello – I can make one. We can make one. This is just what I have and I do have this from my vet you guys can have.

Mr. DeMio - We can have that?

Ms. Parrinello - Yes.

Mr. DeMio - Anything you want to give us...

Ms. Parrinello - Yes.

Mr. DeMio – We'd be glad to take.

Ms. Parrinello - Yea, I can make a copy of this; but this, you can have this. I made this for you guys.

Mr. DeMio - When you're done, just, Aimee is going to keep the record...

Ms. Parrinello - Okay.

Mr. DeMio - For our council.

Ms. Parrinello – That's really all I have to say. Just, I think it's worth another look. Especially, I don't know if that's something that had been brought to anybody's attention before. It certainly wasn't brought to mine.

Mr. DeMio - I understand. If you don't mind. Thank you.

A copy of Ms. Parrinello's document is attached to the back of the minutes.

Mr. DeMio - Okay. Thank you so much and thank you both for being respectful to us as well.

(Applause)

Mr. DeMio – Anyone else would like to come up? Just...first come, first serve.

Ms. Kime – I'll be quick.

Mr. DeMio – That's fine.

<u>Lisa Kime, 20434 Prairie Meadows Place, Strongsville, OH:</u> I hadn't planned to speak. I'm Lisa Kime and I live here in Strongsville. 20434 Prairie Meadows Place. And I've just came...

Mr. DeMio - Hey Lisa, can you spell...

Ms. Kime - K-I-M-E, sorry.

Mr. DeMio - And Lisa is spelled commonly, right?

Ms. Kime – L-I-S-A.

Mr. DeMio - Okay

Ms. Kime – So, I hadn't plan to speak...

Mr. DeMio – And you're address please.

Ms. Kime - 20434 Prairie Meadows Place.

Ms. Pientka – Thank you.

Ms. Kime - Yep; but, I was curious, because I am very involved in animal rescue and I know about the legislation. That was the "Petland Legislation" and that was a direct attack against Grove City that passed legislation that didn't allow stores to, you know, procure elsewhere or from puppy mills. And also, with House Bill 506; which the young lady just mentioned; but, after hearing the story I felt complied to come up and talk about my personal experience with Mr. Collins. I'm with Golden Retriever Rescue. I'm president of Golden Retrievers in Need. We've been around 26 years. We have about 600 members. I live here in Strongsville and we, unfortunately, have been on the receiving end of a number of dogs that have come from Pick of the Litter. Dogs that would break your heart. Dogs that are sick, flea infested and probably more, more importantly, just emotionally damaged. Dogs that have same kind of vet records, handwritten vet records, no labels off the medication, questionable ages; and so from a health prospective, and I'm glad to hear you are sending health inspectors out and that the Board of Health has been out, I think that's a great thing; but, I mean the problem is really our culture, right? If we weren't buying dogs from there, they won't be in business and so it's an education piece and I know our rescue is very passionate about that; but, I hope that in light of House Bill 506 that this council and this city, maybe that gives you some teeth to, you know to do further investigation into the pet store. I think that...certainly if you've gone in there, you know that the conditions are horrible...

Mr. DeMio - And rest...I thought you were done. Go right ahead...

Ms. Kime – Yes, no; so, again, I'm just attesting to what we've seen. We get calls when they get Golden Retrievers in that store. Our rescue gets inundated with calls like, "Oh my gosh! There's a Golden there. You've got to go save it." And frankly, we've had members go in and buy dogs and give them to the rescue. Now that really doesn't help the calls in the long run; but, they feel sorry enough for them that they feel like need to be rescue. Again, just lending testimony to what we already know is a problem and hopefully, with enough education, we can work together and...

Mr. DeMio – And I may say this, and I'm not saying anything that will surprise the Mayor or Neal. Neal takes copious notes. He reviews everything we do. If there is something he's going to advise us on that will come at a later date, especially this is a three day old piece of legislation that was passed.

Ms. Kime -- Yes, there was a puppy mill with the Humane Society of the national...

Mr. DeMio - Say it one more time.

Ms. Kime – The National Humane Society. There was a big puppy mill push in Ohio. There was a grassroots effort. We were collecting signatures; but, the legislation passed on its own. I think it's something that's worth looking into and hopefully that will give you some teeth to perhaps make some positive change. Thank you.

Mr. DeMio - Thank you so much for coming up.

(Applause)

Mr. DeMio – Okay, give us one second. (Unintelligible) private stuff here. Go right ahead. Name and address, please.

Nelli Johnson, 1546 Oakwood Drive, Cleveland Heights, OH: Hi, I'm Nelli Johnson. I live...

Mr. DeMio - Okay, go right...even though its common spelling, just spell it all.

Ms. Johnson - N-E-L-L-I, J-O-H-N-S-O-N

Mr. DeMio – That's fine and you're address please?

Ms. Johnson – 1546 Oakwood Drive in Cleveland Heights.

Mr. DeMio – Okay.

Ms. Johnson - My family has lived in Strongsville for a while...

Mr. DeMio - Can you adjust the mic, if you wish.

Ms. Johnson – Okay.

Mr. DeMio - There you go.

Mr. Johnson – Okay.

Mr. DeMio - Thank you.

Ms. Johnson – Well, undoubtedly, many of you have rescued dogs and cats yourself and haven't paid \$500.00 for fancy dogs and undoubtedly you already know about the problems with puppy mills. There are six million cats and dogs in the United States every year that are euthanized. There's too many. We don't need pet stores and we don't need to deal with that problem and I have a solution. You may not be able to regulate the hours, the cage sizes; but you have the ability to ban pet stores in Strongsville. That is what I am asking you to do. Thank you.

Mr. DeMio - Anyone else?

Mr. DeMio - Anyone else? I've think you've heard enough, state your name, spell it, address...

Tom Collins, 4162 Grafton Road, Brunswick, OH: Tom Collins, T-O-M, C-O-L-L-I-N-S. I own Pick of the Litter.

Mr. DeMio- We need an address for the record.

Mr. Collins – 4162 Grafton Road, Brunswick, OH. I just want to say one thing, I know the difference between a four week old and an eight week old puppy. A lot of vet techs know everything and they don't know everything. I've been in business for 35 years. I rescue cats, I rescue dogs, and if I could bring a whole slew of people in here but I didn't want to bring in them in here to the city council meeting and start a bunch of garbage. I do not buy from puppy mills; I buy from local breeders, not like some pet shops do. I don't buy out of state from brokers. This woman that just came up wants to shut my business down, just like in California. A year ago, my buddy's father ran into a girl downtown in an elevator. She had a runny nose, snot blowing out of her nose, coughing. He goes, "Honey, you've got a bad cold." She goes, "Yeah, I was up at this pet shop yesterday protesting, that right-wing motorcycle piece of crap." So it isn't all about puppies. I get up every morning at 3:30 a.m. and I bust my rear end and I get in there and clean that shop and I check every dog and I make sure they are healthy. If there is a problem with this girl's dog, why didn't she come back and contact me? Come back and talk to me. They are like my kids and I've been doing it for 35 years and I don't need some left-wing radical idiot trying to close me down. You know what? I've got a picture of Jesus Christ hanging in my shop and they don't like that picture of Jesus either.

Mr. DeMio - Folks, it's very emotional...

Mr. Collins – Pictures do not do it justice, come in yourself and see my shop. That's all I ask. Pictures you take...you take a picture of a little corner of the aquarium and there's six feet of gray in this way. A guy goes online and mentions, "Look at this dog with these tumors on it," but he doesn't go to the other end of the six feet tank and read the sign that says, "Hernia surgery, September 13th." He puts it online and gets everybody to hate my guts. I've got people in China hating my guts. This has been my living for 35 years. I have rescued cats and dogs and I take every cat off the street. If somebody comes in and they got cats with respiratory problems, I treat them and take care of them. That's all I have to say.

Mr. DeMio - Thank you.

(Applause)

Mr. DeMio – Okay folks, we just have to remain in order in our council chambers. We appreciate that it is very emotional. I know Mr. Jamison is going to take a look at everything that he got today and I thank Aimee for collecting anything. I appreciate it and I mean it. I appreciate all of you coming. This council appreciates everything everyone is trying to do, whether it is the owner or the folks that want to stop the owner from doing business. This council is always an open mic so I thank you very, very much and I really appreciate everyone being respectful. I think that was an awesome, very professional way to do business. I mean that, so I thank you all very much. I thought everyone was done, but go right ahead. Just your name, address, spell it...

Meredith Hawk, 250 Hedgecliff Drive, Aurora, OH: My name is Merieith, M-E-R-E-D-I-T-H, last name is Hawk, H-A-W-K. Hive in Aurora, 250 Hedgecliff Drive. I'm a director of a rescue, a purebred rescue, and I'm a volunteer. I just wanted to say we're kind of the front line for dogs that come from places like Pick of the Litter. If you saw the condition the parents come from, you know when they come from the puppy mill, or the puppies that get turned into us for their health problems, the deformities...we try to save them and get them into homes. It's just hard. Something needs to be done about it, it really does. We're with the purebred rescue so we see a lot of it, a lot of dogs that have parents have horrible conditions; they are not treated well; they're health conditions are not taken care of. I've had dogs, my own dog, has come from a store like Pick of the Litter. She came from Petland. She has very severe emotional damages.

Mr. DeMio - Thank you, go ahead, you can finish please.

Ms. Hawk – It's just hard with the noise in the background. The disrespect.

Mr. DeMio – I understand.

Ms. Hawk – When you're trying to take care of these animals that have been left in this condition so somebody can make a profit. Being with a rescue, we're not making a profit. We probably spend about \$3,000.00 on each dog and we adopt them out for \$250-\$300. That's what rescue really is. We're taking these dogs that are in this bad shape and it needs to be stopped. It really needs to stop.

Mr. DeMio - Thank you so much.
