

SUMMARY OF CAUCUS DISCUSSION AND MINUTES OF THE STRONGSVILLE CITY COUNCIL REGULAR MEETING HELD ON, MONDAY, MARCH 21, 2022.

The Council of the City of Strongsville met in the Caucus Room at the Mike Kalinich Sr. City Council Chamber, 18688 Royalton Road, on **Monday, March 21, 2022 at 7:30 p.m.**

Present: Council Members: Annmarie P. Roff, Thomas M. Clark, Gordon C. Short, James E. Carbone, Joseph C. DeMio, James A. Kaminski and Kelly A. Kosek. **Also Present:** Clerk of Council Aimee Pientka. **Administration:** Mayor Thomas P. Perciak, Law Director Neal M. Jamison and Finance Director Eric Dean.

Council President Jim Carbone called the caucus to order at 7:30 p.m.

Public Service & Conservation Committee: Chairman DeMio advised Ordinance Nos. 2022-043 through 2022-045 all pertain to amending certain sections of the codified ordinances pertaining to tree fees. Planning Commission gave all of these a favorable recommendation. Ordinance No. 2022-043 will be placed on second reading and set for a public hearing. It is required to have a public hearing as it amends Chapter 12 of the codified ordinances. The recommendation for the other two is to suspend and adopt. Ordinance No. 2022-049 is to approve and ratify the purchase of specialty repair parts and supplies in 2021 for the city's service department truck fleet. This is without public bidding so all seven votes are needed for this legislation to pass.

Finance Committee: Chairwoman Kosek recommended suspension and adoption for Ordinance No. 2022-050; an appropriations ordinance for the annual expenses and other expenditures of the city. Two million dollars of this is from the American Rescue Plan funds that will go towards street repair.

Planning, Zoning and Engineering Committee: Chairman Kaminski recommended suspension and adoption for Ordinance No. 2022-051; an ordinance amending Chapter 1058 of the codified ordinances concerning storm water management and sediment and erosion control. Mayor Perciak advised the city is doing this because of the EPA and all of the updates and permit requirements they have brought forward. Mr. Jamison advised these are recommendations, made by the EPA and the sewer district, that go out to all communities in this area.

Mr. DeMio advised a resident reached out to him today regarding living on a street that just had the sanitary sewers put in. She had some questions regarding the owner's responsibility to tie into the sewer lines. Mr. Jamison advised this scenario happened before during one of the city's first projects on Webster Road. A resident there refused to tie in. That enforcement responsibility went to the Board of Health. In that situation, they went to court to get the appropriate relief to enforce their authority to make her tie in. She still refused and the Board of Health then taped off that house and it is still currently unoccupied.

Committee of the Whole: Mr. Carbone recommended suspension and adoption for Ordinance No. 2022-052; an ordinance approving and adopting replacement pages to the codified ordinances of the city for the last half of 2021 and through February, 2022.

MINUTES OF THE STRONGSVILLE CITY COUNCIL REGULAR MEETING HELD ON MONDAY, MARCH 21, 2022 IN THE MIKE KALINICH SR. CITY COUNCIL CHAMBERS, 18688 ROYALTON ROAD, STRONGSVILLE.

CALL TO ORDER:

Council President Jim Carbone called the meeting to order at 8:00 p.m.

Commander Randy Howson and the Honor Guard from the Military Order of the Purple Heart led in the Pledge of Allegiance.

CERTIFICATION OF POSTING:

The Clerk of Council certified that the meeting had been posted in accordance with Ordinance No. 2004-273.

APPROVAL OF MINUTES:

The Minutes of the Regular Council Meeting held on March 7, 2022 were approved as submitted.

APPOINTMENTS, CONFIRMATIONS, AWARDS AND RECOGNITIONS:

Purple Heart recognition presented by Commander Randy Howson, Department of Ohio, Military Order of the Purple Heart.

At this time, Mayor Perciak presented Commander Howson with the Purple Heart proclamation, recognizing Strongsville as a Purple Heart City.

(Applause)

Mr. Howson – Thank you Mayor, we have done...I think the 38th city we've done in the State of Ohio; and we are certainly honored to be here in Strongsville. I came up last fall...Charlie and I came up to Parma and we had a couple of your citizens at that ceremony and we borrowed an Honor Guard that night because we had some injuries. Unfortunately, we couldn't pull it together tonight because of the quick injuries, quick notice; and unfortunately, we couldn't reach out to our fellow veterans and have them show up with us and we feel sorry for that. We are proud to be here. This means that there is another community in Ohio that is proud to fly the United States Flag. Kneel when you pray to God and you're not afraid to sing the National Anthem and show the love for our country no matter what the cost. Mayor, I'd like to award you, on behalf of the 8,000 members in the State of Ohio and the 43,000 members nationally of the Military Order of the Purple Heart, we give you the special recognition award that is bestowed with pride to the City of Strongsville, Ohio for your dedication and support honoring America's combat wounded veterans by becoming a Purple Heart City. Presented by the patriot members of the Department of Ohio, Military Order of the Purple Heart.

APPOINTMENTS, CONFIRMATIONS, AWARDS AND RECOGNITIONS (cont'd):

Mr. Howson – I would like to clarify that this award is recognizing the municipality, the city, it's not any one veteran; it's not one kind of flavor veteran; it's not one branch of veterans; it's the municipality of being a veteran-friendly community to all veterans. We just happened to be the people that are chartered by Congress to be authorized to designate municipalities as Purple Heart cities. We have a thing we've added onto our ceremony as a remembrance. You get a Purple Heart coin for each member present tonight.

Mayor Perciak – Thank you.

The Honor Guard closed the recognition with the playing of Taps; for those veterans who did not return home.

REPORTS OF COUNCIL COMMITTEES:

SCHOOL BOARD – Mr. Clark: The most recent school board meeting was on March 10th and that school board meeting took place at the Polaris Career Center. A couple of things of note during the March 10th school board meeting. One, that it was at Polaris and, of course like all meetings, President Micko who was in the audience a moment ago and we have Laura Housum from the school board here tonight as well, they begin their meetings with their focus academic achievement, financial prudence and community engagement. I think it's very fitting that we were there at Polaris to show off a \$60 million project that had been completed. It was in a new restaurant inside the Polaris Center that's run by students and was upgraded. They talked a lot about the return on investment of that. The meeting began with highlights. One of those highlights was Moody's, an outside party similar to some of the agencies that give us our financial prudence ratings and our own Strongsville City Schools, but Moody's reevaluated Polaris and Polaris was awarded for a vocational school district rated "aa1" stable for their consistent operating performance. Again, President Micko spoke about the kind of the role model that Strongsville as a city provides and certainly, we've seen that same strong financial prudence in our schools; and it's nice to see our partner Polaris on the same token. The superintendent of Polaris is Bob Timmons and he certainly welcomed the meeting being there; but he also recognized President Micko because that \$60 million project began when President Micko was serving as the Polaris superintendent. The biggest thing to exemplify for the return on investment was that this coming fall, they are at 110% capacity. To invest that and to see the students be able to be completely full for classes was just great. Just one other thing to focus on from the meeting of March 10th; Jessica Frenchik was one of the speakers that night. She's an integration specialist in our school district and she talked about the return of investment of her program; and again, a great partner because she's also the vice president of the Strongsville Chamber. Just a good school board meeting from the school's standpoint. That was nice to attend and nice to be at it there. Our Council President wants to comment on one other thing associated with the school board.

Mr. Carbone – Yes, we had a young lady here at the last council meeting that spoke during audience participation, Mackenzie Schulz. Mackenzie headed of Stand Up in Strongsville for leukemia and lymphoma. She met her goal and then some. This young lady, in a couple of months, raised \$85,000 for leukemia and lymphoma. It's very fitting...Stand Up in Strongsville, awesome that Strongsville stood up and supported it on a day that would have been the 19th anniversary of my dad's passing. I was part of the grand finale celebration...they raised over a million dollars. An exceptional person and it's exceptional to have her in our Strongsville schools with many others. I wanted to point that out because she did come to the council meeting a couple of weeks ago. Great job Mackenzie, we are all very proud of you.

That concludes my report for both committees but I will happily take any questions.

PUBLIC SERVICE AND CONSERVATION – Mr. DeMio: Thank you so much, this committee has Ordinance Nos. 2022-043, 2022-044, 2022-045 and 2022-049. A quick update on Ordinance No. 2022-043; this is amending a section of our code; so we're going to have a public hearing on May 2nd at our council meeting to do that. Ordinance No. 2022-044 is updating the tree fees. Ordinance No. 2022-045 is the tree planting fund range table. Ordinance No. 2022-049 is all 7 must vote. This is a non-public bidding ordinance for repair services by the city's international truck fleet. As the Mayor said earlier in caucus, they're the only game in Ohio that does this service; so therefore, it would be moot for us to go out for bid and it would just take time. We want to always be ahead of the game on these. With that said, we're voting on the ordinances; and again, Ordinance No. 2022-043 will be a second reading and a public hearing on May 2nd at 8:00 p.m. That would be it...

Mr. Carbone – Any questions for Mr. DeMio?

FINANCE – Ms. Kosek: Yes, we have one ordinance on the agenda tonight; it's appropriations Ordinance No. 2022-050. It represents a \$2,977,750.00 over our original numbers. Our Finance Director, Mr. Dean, prepared a report for everyone that has the 9 items that are changing. The one that is probably the most important to us is the largest, which is about 2/3 of this increase, is related to the road repair project, which we are getting the funds from the American Rescue Plan Act which is related to all of the COVID. If anyone has any questions, I will try to answer them or refer them to our finance director; but otherwise, I ask that everyone suspend and adopt.

PLANNING, ZONING AND ENGINEERING – Mr. Kaminski: Yes, Planning, Zoning and Engineering has one ordinance this evening; Ordinance No. 2022-051; it's amending Chapter 1058 which is concerning storm water management, sediment and erosion control. They are recommendations by the EPA. The recommendation is suspension and adoption on that ordinance this evening.

Mr. Kaminski – Just a quick comment...

Ms. Roff – We do have...yes, tonight's the last night. Are you going to announce that?

Mr. Kaminski – You can announce that, that's fine.

Ms. Roff – Sorry, was that what you were going to announce?

Mr. Kaminski – No, recreation...it was a young lady, a Kristo Allison, she's "Miss Wheelchair Ohio." She was able to actually meet with Bryan, the director of recreation, today and actually provide the input early on to some of the center of town projects; and she will continue to meet with him on an ongoing basis as more plans become available for her to review. I think it's great to have that input early on.

Mr. Roff – Thank you for sharing that and then one other thing, tonight is the last night to sign up for Safety Town. I'm sure they'll take late...but it will be preference to those who have signed up by midnight tonight.

Mr. Kaminski – The most common question we get on that is those that are entering kindergarten.

Ms. Roff – Correct, entering kindergarten.

Mr. Carbone – You missed the cutoff Mr. Mayor.

COMMUNICATIONS AND TECHNOLOGY – Mr. Carbone:

MAYOR PERCIAK: Thank you Mr. President, just a quick thank you to the Strongsville Chamber of Commerce for hosting the annual State of the City address; and to the 200-250+ people that attended. Thank you so much for the interest in our community. Thank you so much for the support of this administration and Council and the directors of our community. I appreciate the feedback and the comments from everyone. Thank you to the councilmembers for attending. That ends my report.

FINANCE DEPARTMENT – Mr. Dean: Thank you Mr. President, upon review of the agenda for tonight, I hereby certify that funds will be made available for all ordinances and resolutions on such agenda requiring certification of funding, thank you.

REPORTS AND COMMUNICATIONS FROM THE MAYOR, DIRECTORS OF DEPARTMENTS AND OTHER OFFICERS (cont'd):

LAW DEPARTMENT – Mr. Jamison: All ordinances and resolutions are in proper legal form. That concludes my report.

Ms. Roff – If you don't mind going back to the Mayor's State of the City address. If we could just go over it a little bit because I have gotten some phone calls of what exactly we're looking at; at the top of...I know the Mayor made an announcement which, of course, people now want to know when, where and how for the I-71/Boston...if you don't mind going over that just a little bit.

Mayor Perciak – Yes, I can, there is going to be a follow up meeting with ODOT, the engineers and everyone on Monday, the 28th at 2:00 p.m. It's a Zoom meeting. That is the next step and Neal Jamison, our law director, will be receiving the terms and conditions of the first \$100,000.00 grant; which we hope to have available and present to the Council for their acceptance and approval; if not at the next Council meeting, the one thereafter. This is the beginning of a long process. As I announced at the State of the City. I want to thank Tom Patton for his work on this project; and Speaker of The Ohio House, Judge Cupp, for all his work for coming to Strongsville and helping to facilitate all that. As I announced at the State of the City, this really started under the leadership of Mayor Walther Ehrnfelt and Mary Rose Oakar; at that time, our Congresswoman who happens to be Joe DeMio's aunt. Mary Rose was very instrumental. For some reason, this was long before any of us were in public office, that did not go through and the only one available to talk to today as to why and how come is maybe Charlene Barth. Other than that, it's back to square one. I do not know, and neither does the law director at this point, whether Brunswick is going to partake. That will add another whole set of circumstances. Any of the residents that may be calling you, the best thing to do at this point is either refer the call to our engineering department or me; or to Representative Tom Patton. This is a long, drawn-out process. I do not know how long it will take; but because of the pending award towards engineering, it was the right time to make the announcement.

Ms. Roff – Thank you, I just know we have some studies from NOACA.

Mayor Perciak – We've got studies, and I'm not exaggerating, that are stacked probably 4 feet tall; so I can't...

Ms. Roff – It just showed some of the designs and different options. I didn't know if we were going back to any of that stuff.

Mayor Perciak – Not yet, because it all depends what Brunswick is going to do. If Brunswick is not partaking, there's going to be an exit ramp going south off of Boston, and an entrance ramp going north off of Boston, period. Now, should Medina County and the City of Brunswick decide to join, which we had hoped they would do; but I was told that they didn't want to participate at this time as was Representative Patten, as was ODOT and NOACA. As soon as it's been determined whether they are going to be a player or not; I'll let everybody know; but as of today, I received no official word that they are going to be participating. There's been discussion, but no official word.

Mr. Short – And Mayor, just to be clear, this first \$100,000.00 is again, like you said, a long process...the first step. This is again an engineering study?

Mayor Perciak – Yes

Mr. Short – On this potential...

REPORTS AND COMMUNICATIONS FROM THE MAYOR, DIRECTORS OF DEPARTMENTS AND OTHER OFFICERS (cont'd):

Mayor Perciak – Yes, because there are so many players between ODOT, NOACA, us and all the different agencies that are going to be involved in this.

Mr. Short – Like you said, it will be years.

Mayor Perciak – I didn't say that.

Mr. Short – At least we're starting.

Mayor Perciak – I said I don't know the timeline and when you get so many players involved in a process, as you know from your days in Columbus; it's not an easy thing.

Mr. Short – That's at least a good first step, thank you.

Mr. DeMio – You know, I don't want to go down memory lane, but in 1988 when I was a wee, bitty-boy, I actually had to speak at the high school regarding that funding; and Wally Ehrnfelt was there. It was really funny, there's was only like 7 or 8 people there; and I just read off a little sheet of paper my aunt gave me from D.C. Then, fast forward to 1995 Mayor, that's when I really got a chance really to know you. I won my first election; and sure enough, Jimmy Kaminski and Charlene Barth were with me. We went to Brunswick and went over all these different plans. There was 24 different plans; and I learned about a "B intersection" – one that would stagger Howe Road and Hunt Road and Carpenter Road and how that would all work. Then it died...then it came back up in 2000, right? Then there was a change in Congress and that money went away and there was some political fighting between...I'll just say the Mayor and the new Congressperson didn't see eye to eye. We'll leave it at that; and that's pretty much what happened. The Mayor is shaking his head but he didn't say...he knows the story.

Mayor Perciak – Pretty much.

Mr. DeMio – Yes, so, it's been a long time. I believe the original project was somewhere around \$8.5 million dollars; and now it's up in the \$20s+.

Mayor Perciak – We wish, we wish it would be in that ...

Mr. DeMio – That was the first time I ever really got the chance to meet Wally Ehrnfelt, outside of the Westside Market.

Mr. Carbone – That's exciting news, I think we would all love to have that partnership with Brunswick; but the issue is in our community; and I think the ramp...the partial ramp off of Boston connecting with North Carpenter; and then southbound from Boston Road cutting through Benbow is a realistic plan. If we all have to champion it, champion the plan; and I'm glad that we are looking into a realistic solution for Boston Road; not one that is 50-60 years that we were chasing that...

REPORTS AND COMMUNICATIONS FROM THE MAYOR, DIRECTORS OF DEPARTMENTS AND OTHER OFFICERS (cont'd):

Mayor Perciak – We have a lot to do. You're right Jim, and it's about time. We have to do something with the traffic there. Ann, I know you live on Howe Road. Eventually, something needs to...we're going to have issues moving forward and I discussed it with the county. Emergency vehicles getting down there is more and more troubling with each passing day. Something is going to have to happen there for the safety of everybody concerned. Then, I'll only say we...and sometimes directors get a little irritated with me. We always need to ask. We always need to never leave any rock unturned. Kelly Kosek was a part of the earmark money for Prospect Road at the time. I'll tell you, Gonzalez just went overboard, along with our Montrose group and everybody who took a part in this money; and to get the call from Gonzalez that the money was going to come to us. I still haven't received a letter yet; but when a Federal Congressman calls you and says the money's coming, I believe him. It is going to come so as soon as we get that...a matter of fact, our law director asked the engineering department today whether they received anything in writing from them so that he could move on it on this side here; and the engineer's done – we would love to get going on that.

Ms. Kosek – That was going to...my question is do we have...assuming the money comes in, we'd be ready to go?

Mayor Perciak – Well, Neal, that's for him to answer.

Neal Jamison – Yes, so it's a process. We have to get it first and my understanding is we're not close to getting it; but we'll keep monitoring it.

Mr. Carbone - And just to go back to the partial ramp at Boston Road; and that we are going to have to do something with Howe Road. We have to make Howe Road more efficient so we don't cause another traffic issue at Boston Road.

Mayor Perciak – Well...

Mr. Carbone – so it's a long process. There's going to be many, many things we have to do to get to that point.

Mayor Perciak – Well, but you see, at the same token Jimmy, if Brunswick...when they were working with all the different agencies to widen North Carpenter; that is when all of this should have gone into play. As all of you know, it just has sidewalks; and of course, they eliminated all the drainage ditches. They did a beautiful job; but as it sits today, North Carpenter, nor is Boston Road right there, capable of handling the traffic and that, therefore the traffic studies; because when you're going to be having all these cars exiting over there, we have to be able to...especially the intersection at Boston Road and Howe Road – that is going to need a lot of work in order to facilitate the traffic that could be coming off there. So, that's what I'm saying, there's a lot more to this than meets the eye; and it is more than just a ramp because we have to decide what work. The engineers from all the players have to decide how this traffic is going to go...so buckle up.

Mr. Carbone – Exciting news, I think we're all ready for it. I think the community is ready for it.
