A RESOLUTION ACCEPTING THE DONATION OF A CUSTOM MADE MOBILE RECEPTION DESK FROM JUSTICE & COMPANY FOR USE AT THE WALTER F. EHRNFELT RECREATION CENTER.

WHEREAS, the Ehrnfelt Recreation Center daily hosts numerous events and programs for the benefit of its members and Strongsville's residents; and

WHEREAS, in order to facilitate the orderly process of checking in patrons who will participate in such events and programs, Justice & Company has offered to donate a custom built, mobile Reception Desk made of cherry veneer with handmade glass tiles and a granite top, valued at approximately \$6,641.20, to be used in the Avenue area of the Ehrnfelt Recreation Center; and


WHEREAS, the City is therefore desirous of accepting such gracious donation;


Section 3. That this Resolution shall take effect and be in force immediately upon its passage and approval by the Mayor.

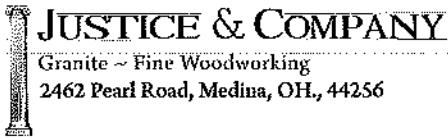
