Mr. Yankovich — I am requesting approval for a replacement sign with individual channel letters. A new pediatric dentist is taking over from the Hudson area and we would like to reuse the pediatric dentistry portion of the sign. We will have to move the sign so that it is more centered on the tenant space and wall area. We are also asking for 20" high individual channel letters, which will read "Strong: and 14" overall height, which will read "Smiles. That is their new location name and it is also their brand. The letters are 5" deep with an enamel white return; the faces are a translucent white; backlite white LED illumination; 1" perimeter white trim that holds the faces on to the sides. We are attaching all the forms on to the rear raceway and try to match the existing sign that is there, so that it looks consistent. It will all match as close as possible.
