The following was discussed:

STRONGSVILLE UNITED CHURCH OF CHRIST: Mrs. Daley stated they would like to construct a storage shed/pavilion at the corner of Pearl and Royalton Road. They would like to locate it in the large grass area west of the church and the parking lot. The City Planner, had no issues. From the Engineering Department, it is in approvable form.
