MINUTES OF THE STRONGSVILLE CITY COUNCIL SPECIAL MEETING HELD ON TUESDAY, JULY 25, 2023 IN THE MIKE KALINICH SR. CITY COUNCIL CHAMBER, 18688 ROYALTON ROAD.

### **CALL TO ORDER:**

Council President Pro Tem, Kelly Kosek, called the special meeting to order at 5:03p.m. All joined in the Pledge of Allegiance to the Flag.

Cindy Zanzano, 19256 Royalton Road, Strongsville, Ohio 44136: My name is Mrs. Cindy Zanzano, my address is 19256 Royalton Road. I happen to live across the street from the property, and I happened to take care of the old man that lived on that property for many years. What is there for us to say?

# PUBLIC HEARING (cont'd):

Ms. Zanzano (con't) - First and foremost, you guys have already traded properties; we don't have a choice. You are building there from what we understand. So, what can I say? You are going to do it whether we want you to or not. We know you are building a fire station. Living there, for one thing, there is no Jake Brake and it's like living on drag way Route 82. The traffic being...how are the guys going to get out and save anybody? That is the worst place to put, I mean, a fire station that I can imagine. You had one right here and you all took it away. You have four beautiful fire stations and now you want to build one again in downtown. It doesn't make much sense to me. As seeing how you took it all away, how are the trucks going to get in and out? I don't mind them saving people, but it just seems like a whole waste of money. It's a really beautiful property and I think you all could have done something with it. I want to know if and when they are going to do anything about the people going through the traffic lights. They are all down at Muraski through the school zone which is wonderful. I'm not complaining, but when you are travelling on Route 82 headed either way, east or west, the people run through the traffic lights; especially the turning ones...especially the ones that are headed south. There are eight to ten people, and nobody seems to be paying attention. They are hot rodding up and down the street at 120 mph on motorcycles. Could we get some kind of help at least something to slow it down? I just think the fire trucks are just going to make it worse, thank you everybody.

Ms. Kosek – Thank you is there anyone else who would like to be heard in opposition of the ordinance? I'm sorry Charlie, did you want to...?

Marissa McNabb, 19259 Westwood Road, Strongsville, Ohio 44136: Marissa McNabb, 19259 Westwood, and we are directly behind them. We already hear sirens constantly. I understand that's a good thing that they are getting everywhere; but they had one fire station in the center of Strongsville, and then they decided to branch off to bring all these other fire stations to the outside. I don't understand why they are going to bring it back to the center of town. We live in the center of the city, and there is so much that the city is trying to. At the same time, it's almost like they are pushing us out; the people that have been here long enough or the longest. It seems like they are doing their best to just kind of push us out. I have kids, and I'm raising the kids there. They ride their bikes down the street, and half the time the cars almost hit my son. There's a lot going on already in the center of Strongsville. I'm just curious why they decided to bring it back to the center where it was good; then they decided to branch off. It seems like there is one in every corner. I don't know what that will do, bringing one back in the center, that's all.

Ms. Kosek - Thank you, Charlie did you want to speak?

Mr. Goss – To address the issues that were raised?

Ms. Kosek – Yes, please.

Mr. Goss – First of all, I took notes on the traffic complaints, and I would be happy to talk to you about all the dynamics that were in play when this fire station at the center of town was closed. This facility that we are in now, could have never been built because of the size of the footprint. Back then, twenty years ago, the data suggested different things of what has developed over the last twenty years. There will be a lot of conversations. I will be glad to meet with you privately to give you a lot of details, so that you really understand what's taking place; how we got to where we are now, and where we think we need to go moving forward.
