ORDINANCE NO. 2022 - 150

AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO ISSUE AND APPROVE CHANGE ORDER NO. 1 FOR AN EXTENSION OF THE CONTRACT COMPLETION DATE, WITHOUT CHANGE IN PRICE, AND IN ACCORDANCE WITH THE PROVISIONS OF THE CONTRACT BETWEEN THE CITY OF STRONGSVILLE AND FABRIZI TRUCKING & PAVING CO., INC., IN CONNECTION WITH THE 2021 PAVEMENT RECONSTRUCTION PROGRAM, IN THE CITY OF STRONGSVILLE, AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to Ordinance No. 2021-072, Council authorized the Mayor to enter into a contract with Fabrizi Trucking & Paving Co., Inc. ("Fabrizi") in connection with the 2021 Pavement Reconstruction Program; and

WHEREAS, as indicated in the Notice to Proceed referenced in Section 2 of the Contract documents, the work was to be commenced no later than July 5, 2021 and must be completed within Four Hundred Fifty (450) consecutive calendar days thereafter, being September 28, 2022; and

WHEREAS, due to circumstances beyond the reasonable control of the contractor such as material shortages, delays and increasing cost of the materials, rising fuel costs, along with labor and driver shortages, Fabrizi has been unavoidably delayed in completing the work as required by the contract terms; and

WHEREAS, Fabrizi, therefore, has requested an extension of time of Three Hundred (300) calendar days to complete the work, with a new contract completion date of July 25, 2023, at the same contract price; and

WHEREAS, the City's Engineer has recommended that due to such extenuating circumstances, an extension of the time to complete work by July 25, 2023 would be warranted and is reasonably required at this time.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1. That the Mayor be and is hereby authorized and directed to issue and approve Change Order No. 1 to extend the contract completion time from September 28, 2022 to a new contract completion date no later than July 25, 2023, as determined by the City Engineer and the contractor, all in the form attached hereto as Exhibit A, but at the same contract bid price.

Section 2. That the funds for the purposes of said contract have been appropriated and shall be paid from the General Capital Improvement Fund.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council; and that all deliberations of this Council, and of any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare of the City, and for the further reason that the extension of the contract completion time is immediately necessary to provide sufficient time for the contractor to obtain the necessary materials required, to ensure proper quality of the work to be undertaken, and to conserve public funds. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT FOR THE ALBION ROAD AND WEBSTER ROAD SANITARY SEWER PROJECT IN THE CITY OF STRONGSVILLE, AND DECLARING AN EMERGENCY.

WHEREAS, by and through adoption of Resolution No. 2022-126, this Council authorized the Mayor to re-advertise for bids for the Albion Road and Webster Road Sanitary Sewer Project; and

WHEREAS, the City has received such bids for the Project, and Council is now desirous of proceeding to award and enter into a contract for such improvements.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

- Section 1. That this Council finds and determines that the bid submitted by FABRIZI TRUCKING & PAVING CO., INC. for the Albion Road and Webster Road Sanitary Sewer Project meets the specifications on file in the office of the City Engineer, is in compliance with the applicable requirements for bids and contracts established by the laws of the City and the State, and is the lowest and best bid for the contract. All other bids for this contract are hereby rejected.
- **Section 2.** That the Mayor be and hereby is authorized and directed to enter into a contract with the aforesaid lowest and best bidder for the Albion Road and Webster Road Sanitary Sewer Project, in accordance with the plans and specifications on file in the office of the City Engineer, in the amount of \$3,097,303.00, and in a form to be approved by the Law Director.
- **Section 3.** That the funds for the purposes of this Project have been appropriated and shall be paid from the Sanitary Sewer Fund, the collection of special assessments to be levied by the City, and such other State and local funds which may be made available for the Project.
- **Section 4.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.
- **Section 5.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare of the City, and for the further reason that it is immediately necessary to commence such project in order to eliminate hazards and provide for a system of centralized sewage collection, disposal and treatment, to improve properties within the City, and conserve public

AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF STRONGSVILLE ADOPTED BY SECTION 1250.03 OF TITLE SIX, PART TWELVE OF THE CODIFIED ORDINANCES OF STRONGSVILLE TO CHANGE THE ZONING CLASSIFICATION OF CERTAIN REAL ESTATE LOCATED AT 21930 ROYALTON ROAD, IN THE CITY OF STRONGSVILLE FROM GI (GENERAL INDUSTRIAL) CLASSIFICATION TO R1-75 (ONE FAMILY 75) CLASSIFICATION (PPN 392-14-006), AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA, AND STATE OF OHIO:

- **Section 1.** That the Zoning Map of the City of Strongsville, adopted by Section 1250.03 of Title Six, Part Twelve of the Codified Ordinances of Strongsville, be amended to change the zoning classification of certain property located at 21930 Royalton Road from GI (General Industrial) classification to R1-75 (One Family 75) classification (PPN 392-14-006), which property is more fully described in Exhibit "A" and as depicted in Exhibit "B," attached hereto and incorporated herein as if fully rewritten.
- **Section 2.** That the Clerk of Council is hereby authorized to cause the necessary change on the Zoning Map to be made in order to reflect the zoning change in classification as provided in this Ordinance.
- **Section 3.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council; and that all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.
- **Section 4.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare of the City, and for the further reason that it is immediately necessary to rezone such property in order to provide for the orderly development of lots and lands within the City, and to conserve public funds. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.





AN ORDINANCE RATIFYING AND APPROVING THE FILING OF AN APPLICATION FOR FINANCIAL ASSISTANCE WITH THE OHIO DEPARTMENT OF NATURAL RESOURCES DIVISION OF FORESTRY UNDER THE URBAN CANOPY RESTORATION GRANT PROGRAM; AUTHORIZING ACCEPTANCE OF FUNDS, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Strongsville has been a Tree City USA community since 1995, with more than 112,000 trees, which are an integral component of Strongsville's urban environment. Their shade and beauty contribute to the community's quality of life and soften the hard appearance of concrete structures and streets; and

WHEREAS, the United States Department of Agriculture (USDA) Forest Service has supplied the funds for a grant program intended to address the critical need to restore and improve urban forests, reduce storm water runoff, and reduce the impact of climate change, while building resiliency through tree planting in urban communities; and

WHEREAS, in order to meet the deadline for submission of an application to receive these funds through the Ohio Department of Natural Resources Division of Forestry under the Urban Canopy Restoration Grant Program, the City, through its Coordinator of Natural Resources, applied for funding on October 14, 2022 in the amount of \$11,250.00, in order to assist with funding the City's Cost Share Replacement Tree Program for residents who are interested in having a tree planted; and

WHEREAS, the grant is a 50/50 match on a reimbursement basis; and

WHEREAS, if the City is advised that its application for funding under the Grant Program is approved, the City is desirous of accepting such award.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA, AND STATE OF OHIO:

- **Section 3.** That any advance of funds under this Ordinance and/or the City's share will be made from the Tree Fund, subject to reimbursement under the Grant.

Drane Company in order to comply with current State law, be and are hereby approved and adopted; and the ordinances of Strongsville of a general and permanent nature, as revised, re-codified, rearranged and consolidated into component codes, titles, chapters and sections within the mid-year 2022 replacement pages to the Codified Ordinances, be and are hereby approved and adopted, all as set forth in Exhibit A attached hereto and incorporated herein by reference.
- **Section 2.** That any other ordinances or resolutions or parts thereof in conflict with any of the above Ordinances shall, to the extent of any conflict, be and are hereby repealed.
