# SUMMARY OF CAUCUS DISCUSSION AND MINUTES OF THE STRONGSVILLE CITY COUNCIL REGULAR MEETING HELD ON, MONDAY, DECEMBER 19, 2022.

The Council of the City of Strongsville met in the Caucus Room at the Mike Kalinich Sr. City Council Chamber, 18688 Royalton Road, on **Monday, December 19, 2022 at 7:45 p.m.** 

**Present: Council Members:** James E. Carbone, Gordon C. Short, Joseph C. DeMio, James A. Kaminski, Annmarie P. Roff, and Kelly A. Kosek. Also Present: Clerk of Council Aimee Pientka. **Administration:** Mayor Thomas P. Perciak, Law Director Neal Jamison and Finance Director Eric Dean.

Absent: Councilman Thomas M. Clark

Council President, James Carbone, called the caucus to order at 7:50 p.m.

<u>Finance Committee:</u> Chairwoman Kosek recommended suspension and adoption for Ordinance No. 2022-182 which is an appropriation making changes and moving \$4.6 million around to address the city's needs. Mr. Dean noted that overall, this is not an increase to the budget; the \$4.6 million is a transfer out and transfer in on the revenue side which caused a "wash". Mr. Dean also stated that we are placing funds into the operating funds for a carry-over next year.

<u>Public Safety and Health Committee:</u> Chairman Kaminski recommended suspension and adoption for Ordinance No. 2022-183; an ordinance authorizing the Mayor to enter into a contract with Breathing Air Systems for the purchase of a compressed air fill station for the fire department. The contract is in the amount of \$63,285.00 with the city's share of costs, being in the amount of \$6,328.50. Mr. Kaminski also recommended suspension and adoption for Ordinance No. 2022-184; an ordinance to enter into a listing and marketing agreement with Brindlee Mountain Fire Apparatus, LLC to facilitate the sale of an aerial platform truck by hiring a listing agent to help facilitate the sale.

<u>Public Service and Conservation Committee</u>: Chairman DeMIo recommended suspension and adoption for Ordinance No. 2022-185; an ordinance for the Mayor to enter into a contract with Great Lakes Construction Agency in the amount of \$2,634,000.00 for Westwood Lift Station improvements. Mr. Jamison added that this is an overall project for the improvement of our sanitary sewer system and the money will be coming out of the sanitary sewer fund and there will be many more improvement projects to come.

Recreation and Community Services Committee: Ms. Roff recommended suspension and adoption for Resolution Nos. 2022-186, 2022-187 and 2022-188; all being donations for The Town Center Enhancement & Walkability Initiative. Resolution No. 2022-186 is a resolution accepting a donation in the amount of \$50,000.00 from The Strongsville Chamber of Commerce. Resolution No. 2022-187 is a resolution accepting a donation form The Optimist Club in the amount of \$5,000.00. Resolution No. 2022-188 is a resolution accepting a donation in the amount of \$2500.00 from a Strongsville resident, Joyce Reed to be used for a pet water fountain.

Motion by Ms. Roff, second by Mr. DeMio, to approve the Recreation Committee meeting minutes of December 5, 2022. All members present voted aye and the motion carried.

Mayor Perciak wanted to thank Mr. Kaminski and Mr. Painter for their involvement with Ms. Joyce Reed, a member of The Strongsville Rotary Club, who donated the \$2500.00. Without their help, the donation would have not been possible.

Mr. Jamison also added that the donation was a very generous donation in memory of Ms. Joyce Reed's beloved pet, Teddi Rose Velt.

#### SCHOOL BOARD - Mr. Clark:

Mr. Carbone - There was a Strongsville City School Board Meeting on Thursday, 12/8/2022, which Councilman Clark attended and provided the following report. The meeting began with recognition of the OHSAA State Runner-up SHS Girls Soccer Team. The treasurer's report revealed all financial matters to be on track and in alignment with the budget. The board unanimously approved two business matters. The first, approving eight additional magnetic door locks, based on foot traffic studies, to maintain and enhance the safety in our school buildings. The second, approving a bid for two 72 passenger buses with the existing bus fleet lifespan plan. The draft of the 2023 school board meeting schedule indicates and anticipates meetings to continue the pattern of the 2nd and 4th Thursday of the month with the exception being 1/5/23, the January organizational meeting. The Strongsville City Schools are on winter break through 1/2/2023 and the first day back is 1/3/2023.

We want to do our due diligence with the lift station to keep it running properly and in good order. We would again recognize the work that needs to get done and nothing is ever cheap, especially those lift stations. With that, I would like to close, unless there's questions.

**PUBLIC SAFETY AND HEALTH – Mr. Kaminski:** We have two ordinances.
