ORDINANCE NO. 2025 – 026

AN ORDINANCE AUTHORIZING THE FILING OF AN APPLICATION FOR FINANCIAL ASSISTANCE WITH THE CUYAHOGA COUNTY COUNCIL THROUGH THE COMMUNITY DEVELOPMENT FUND; AUTHORIZING ACCEPTANCE OF FUNDS, AND DECLARING AN EMERGENCY.

WHEREAS, the Cuyahoga County Council has announced that funds may become available for community projects through the Community Development Fund; and

WHEREAS, in order to meet the deadline for submission of applications to receive such funding from the Cuyahoga County Council through the Community Development Fund, the City, through its, Director of Parks, Recreation & Senior Services will apply for funding for the purpose of replacing certain equipment at the Walter F. Ehrnfelt Recreation and Senior Center, such as the pirate ship and slide within the Aquatic Center; and

WHEREAS, when the City is advised that its application for funding under the Grant program is approved, the City is desirous of accepting such award.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA, AND STATE OF OHIO:

Section 1. That this Council hereby authorizes the Mayor to submit an application for financial assistance to the Cuyahoga County Council through the Community Development Fund, in the form on file with the City's Director of Parks, Recreation & Senior Services.

Section 2. That this Council hereby approves the acceptance of any award of funding under such Grant program, and hereby authorizes the Mayor, Director of Finance, Director of Parks, Recreation & Senior Services, and other appropriate officers of the City to provide, execute and deliver certifications, assurances and such other information as may be required in connection therewith.

Section 3. That any advance of funds under this Ordinance and/or the City's share will be made from the Recreational Capital Improvement Fund, subject to reimbursement under the Grant.

Section 4. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council; and that all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 5. That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the City, and for the further reason that it is immediately necessary to authorize the submission of such application for financial assistance in order to meet the application deadline, to accept such funds when awarded, and to conserve public funds. Therefore, provided this Ordinance

receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.
