## **ORDINANCE NO. 2025 - 036**

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT FOR MATERIALS AND SERVICES IN CONNECTION WITH THE PAINT STRIPING OF CERTAIN STREETS AND HIGHWAYS WITHIN THE CITY OF STRONGSVILLE, AND DECLARING AN EMERGENCY.

WHEREAS, the City has advertised for and received bids for materials and services in connection with the paint striping of certain streets and highways within the City for the years 2025 and 2026; and

WHEREAS, Council is desirous of proceeding to award and enter into a contract for such purchases.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

- Section 1. That this Council hereby finds and determines that the bid submitted by AMERICAN ROADWAY LOGISTICS for materials and services in connection with the paint striping of certain streets and highways within the City of Strongsville meets the specifications on file in the office of the Director of Public Service, is in compliance with the applicable requirements for bidding and contracts established by the laws of the City and the State, and is the lowest and best bid for the proposed contract. All other bids for this contract are hereby rejected.
- **Section 2.** That the Mayor be and is hereby authorized and directed to enter into a contract for the two-year period of 2025-2026 with the aforesaid lowest and best bidder for materials and services in connection with the paint striping of certain streets and highways in accordance with the specifications on file in the office of the Director of Public Service, and specifically including and accepting Bid Alternates 1, 2, 3, 4 and 5, all in a total amount not to exceed \$893,730.00 for 2025 and 2026 and to be incorporated into a contract approved by the Law Director.
- **Section 3.** That the funds necessary for the purpose of such contract have been appropriated for the year 2025, and shall be paid from the Street Construction, Maintenance and Repair Fund; and the Director of Finance be and is hereby authorized and directed to issue the City's warrants in accordance with the terms and conditions of such bid and contract.
- **Section 4.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council; and that all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.
- Section 5. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare of the City, and for the further reason that it is immediately necessary to enter into said

contract in order to provide for proper and safe streets, the continuity of services and operation of the Service Department, and to conserve public funds. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.
