SUMMARY OF CAUCUS DISCUSSION AND MINUTES OF THE STRONGSVILLE CITY COUNCIL ORGANIZATIONAL AND REGULAR MEETING HELD ON, MONDAY, JANUARY 6, 2025.

The Council of the City of Strongsville met in the Caucus Room at the Mike Kalinich Sr. City Council Chamber, 18688 Royalton Road, on **Monday, January 6, 2025, at 6:30 p.m.** 

**Present: Council Members:** Gordon C. Short, James E. Carbone, James A. Kaminski, Kelly A. Kosek, Annmarie P. Roff, Thomas M. Clark, and Brian M. Spring. Also Present: Council Secretary Marialena Beach. **Administration:** Mayor Thomas P. Perciak, Law Director Neal Jamison, and Finance Director Eric Dean.

Also in attendance was Assistant Law Director Dan Kolick.

Council President, James E. Carbone, called the caucus to order at 6:41 p.m.

The following Council Committees met to review legislation on the agenda:

#### Public Safety & Health Committee:

Chairwoman Roff - I have three items; they are all just housekeeping items. I have Ordinance No. 2025-001; this is to enter into a partnership and will be getting grant money, correct Neal from that?

Mr. Jamison - Yes, this is an annual grant we get from University Hospitals for our OVI Task Force. It's for the amount of \$22,000.00 for the year 2025; and this is something we have done for a long time.

Chairwoman Roff - A suspend and adopt for that; that would be a yes from what I would assume. Then, we have Ordinance No. 2025-002; that is to sell off items that are no longer needed on an approved auction site by the government, so suspend and adopt for that.

Mr. Carbone - It was sad to see the old D.A.R.E (Drug Abuse Resistance Education) Hummer as part of that.

Mr. Jamison - For your information, the chief related that they actually extended the life of a number of these vehicles just to try and get more usage out of them. These were effectively at the end of their effective life.

Mr. Clark - The one that is most recent, is that just high mileage or is there associative damage?

Ms. Roff - There was an accident I believe.

Mr. Clark - An accident?

Mr. Jamison - Yes.

Mr. Clark - Thank you.

Mr. Jamison - That's also like anything else. I guess if you're an athlete and you have injuries, and if you are a car that has accidents, that shortens it's useful life.

Mr. Clark - Yes, thank you.

Chairwoman Roff - The last item is Resolution No. 2025-003; that is to accept a donation to the safety forces there from Northeast Ohio...for the Safety Council of Northeast Ohio, correct?

Mr. Jamison - Yes, and it is actually for our K-9 units.

Chairwoman Roff - Okay; so suspend and adopt for that. That is all I have - all good things.

Mr. Carbone - Any questions for Ms. Roff?

#### Recreation & Community Services Committee:

Chairman Spring - Thank you we have one. Resolution No. 2025-004; this is a resolution accepting a donation of money from The Strongsville Community Theater in appreciation of the personnel at the recreation and senior center. Also, for the usage of various meeting rooms, this is a pretty standard donation to the recreation center. The recommendation is to suspend and adopt.

Mr. Carbone - Any questions for Mr. Spring?

## Planning, Zoning and Engineering Committee:

Chairwoman Kosek - We have one tonight. It's Ordinance 2025-005; this is a request for the approval of a change order #17 related to the Strongsville Town Center project for Gilbane Building Company. It is asking for an increase of \$110,000.00. Neal, based on my review of this, it looks like it's for an addition to staffing and general conditions. Can you give us a little bit more color on what that is?

Mr. Jamison - Yes, so what happened was...because we had extended the time for the project, Gilbane Building Company had to keep their unit out there and their staff out there to follow-up on the job. This is all related to that extra time for Gilbane Building Company to keep their staff in place until the job was completed.

Chairwoman Kosek - Do we...this is inching up to \$9.8 million dollars. Are we done? Is this the last one?

Mr. Jamison - So, engineering thinks that this next one will be the last one and we are pretty much done.

Chairwoman Kosek - Did you say this one? Is there another one?

Mr. Jamison - There's another one probably coming; but she didn't want to make this a final (change order) until she was sure of everything.

Chairwoman Kosek - Okay.

Mr. Jamison - We think we are like 99.9% there. This was just to take care of the Gilbane Building Company because of the extra time. RFC Contracting, LLC who oversaw all this, approved this and said this was legitimate.

Mayor Perciak - Unless it was negotiated down.

Chairwoman Kosek - Okay.

Mayor Perciak - It was substantially higher, and RFC Contracting, LLC - Roger Riachi had a big meeting with them. At the end, that was the final amount. The \$110,000.00 - the final amount at this time.

Chairwoman Kosek - Okay, is everyone satisfied?

Chairwoman Kosek - That is all I have Mr. Carbone.

#### Committee of the Whole:

Mr. Carbone - We have Ordinance No. 2025-006; this is a collective bargaining agreement between the FOP Lodge 15 (Fraternal Order of Police), and the City of Strongsville dealing with our corrections officers. This is through December 31, 2027.

Mr. Jamison - We are good to go on this.

Mr. Carbone - Good to go, yes. The recommendation here is going to be to suspend and adopt. Anything else?

Mr. Carbone - We do have a need for an executive session tonight.

Mr. Short made a motion to adjourn into executive session for the purpose of discussing personnel matters of the Council Office pertaining to the appointment of a public official. It was seconded by Ms. Roff to adjourn from open session into executive session [Article XI, Section 9, City Charter]. All members present voted aye and the motion carried. Council adjourned into executive session at 6:41 p.m. The executive session concluded at 7:40 p.m. and reconvened into open session.
