SUMMARY OF CAUCUS DISCUSSION AND MINUTES OF THE STRONGSVILLE CITY COUNCIL REGULAR MEETING HELD ON, MONDAY, FEBRUARY 3, 2025.

The Council of the City of Strongsville met in the Caucus Room at the Mike Kalinich Sr. City Council Chamber, 18688 Royalton Road, on **Monday, February 3, 2025, at 6:45 p.m.** 

**Present: Council Members:** Gordon C. Short, James E. Carbone, James A. Kaminski, Kelly A. Kosek, Annmarie P. Roff, Thomas M. Clark, and Brian M. Spring. Also Present: Clerk of Council Aimee Pientka. **Administration:** Law Director Neal Jamison, and Finance Director Eric Dean.

Absent: Mayor Thomas P. Perciak.

Council President, Gordon C. Short, called the caucus to order at 6:46 p.m.

The following Council Committees met to review legislation on the agenda:

#### Planning, Zoning and Engineering Committee:

Chairman Spring - Thank you President Short, I have just one today. Ordinance No. 2025-011, which we placed on first reading. This is with the Architectural Review Board. The recommendation today is a motion to amend, with the new amendment, then place it on second reading and refer it to the Planning Commission. Correct, Neal?

Mr. Jamison - Correct.

Mr. Short - Everybody is okay with what we discussed at the last caucus - the changes to the ordinance for the Architectural Review Board, correct?

Ms. Kosek - Yes, thank you Neal for putting that together. I think it looks good with the idea that we are still preferring an architect and a landscape architect, but then preferring city residents if we can't get those professionals. I think that's great.

Mr. Clark - I did reach out to a few contacts. I confirmed the challenge that the city has is not unique to the city and is very challenging in that regard. I think the changes that were made are good and wise.

Mr. Short - Alright, so again, we will motion to amend that, we will vote to amend it, and then we will refer it to the Planning Commission.

#### Public Service & Conservation Committee:

Chairwoman Roff - I have just one item. It is Ordinance No. 2025-012; that is just housekeeping items to get rid of some obsolete things that are no longer needed from our service department. Suspend and adopt is recommended for that.

Mr. Short - Thank you, any questions on that ordinance?

## Public Safety & Health Committee:

Chairwoman Kosek - Thank you Mr. Short, we have two. We have Ordinance No. 2025-013; this is an ordinance to authorize the Mayor to enter into a contract to purchase two ambulances for our fire department. This is with, I believe the government. Is this government pricing?

Mr. Jamison - Yes, this is the State of Ohio Administrative Services.

Chairwoman Kosek - That is the best deal that we can get, and it's just a little over \$800,000.00. Is this a situation where these will be on order for a little while also?

Mr. Jamison - Typically, I think they are taking two to three years to come in. I think you get it in the pipeline and then...so it's planning ahead.

Chairwoman Kosek - Absolutely, I appreciate you guys doing that. I don't know if anybody has any questions.

Mr. Short - Neal, just for that, is one...are they both for the new fire station? Is it depending on time of need when they are delivered?

Mr. Jamison - I think Eric knows.

Mr. Dean - Yes, they are planning ahead. We do have a few order ones, I believe also, but these are planning for the new fire station.

Mr. Short - Alright, thank you.

Chairwoman Kosek - Obviously, suspend and adopt assuming that no one has any additional questions. Ordinance No. 2025-014; this is to authorize the sale of an obsolete police vehicle, which I think it was a 2009 Ford Taurus, and it would go to auction.

Mr. Jamison - The service vehicle is a 2009 Ford Taurus, and the 2015 Ford Fusion is the police. We just put them both in the same ordinance because they are going to the same service.

Chairwoman Kosek - Hooked at the Ford Taurus; and I didn't look at the Ford Fusion, so my apologies.

Mr. Jamison - No problem.

Chairwoman Kosek - Yes, so the Ford Fusion is the 2015 and the Ford Taurus is the 2009. I assume that both have exceeded their useful life. I would ask that we suspend and adopt that unless anybody has any questions.

Mr. Short - Alright, sounds good. We have nothing else on the agenda. Is there anything else that Council might have for the administration?

Ms. Roff - Just really quick though, Neal. I know that sometimes, we've donated some of those items to other cities. Is that not something that we were able to do with the items that Kelly listed?

Mr. Jamison - We've done that on occasion; but the thought process there is that it's going to go to the auto auction, and get at least some money back for taking these out of service.

Ms. Roff - Okay, which is definitely appreciated. I just know that in the past...

Mr. Jamison - We've done that on occasion. I think it just depends on the circumstances and if some of the departments might need it. In this case, there's really nowhere to donate this to.

Ms. Roff - I appreciate that, thank you.

Mr. Short - Does the administration have anything for the Council?

#### Other Business:

Mr. Jamison - Well, I will say, while we are doing this, that we talked at the staff meeting. The Albion Road bridge is anticipated, hopefully tomorrow, they will have one half opened, so that they'll have two traffic signals on each end. The Ohio Turnpike is in charge of that. I guess some concrete fell on the turnpike, so that is why the bridge is closed. The one side is really deteriorated. They have done an evaluation and they feel that they can use the other side. It was scheduled to be replaced this summer anyways; but it obviously deteriorated quicker than they thought. Hopefully, this week it will open up. It will be slower, not as normal, but at least you'll be able to get across.

Mr. Short - Is that something that the Turnpike Commission is handling, and it's not on the city?

Mr. Jamison - Correct, Eric enlightened me this morning that cities don't own bridges. That's usually the State of Ohio - the Turnpike in this case, or the county. Typically, they are responsible for their maintenance and upkeep. If you remember...was it Webster Road? ODOT came in and repaired that about two or three years ago, where the Strongsville's name is on there. Typically, it is the state or county, but in this case, it's the turnpike because it's going over their roadway.

Mr. Short - In regard to service items - I have gotten some calls about water main breaks and water leaks in the city. Obviously, this time of year there's a lot of those in Cuyahoga County. Cleveland Water prioritizes them, works on them as quickly as possible, and determines in their minds, where the most egregious loss of water and breakage is. If you do have residents call you, we are in touch with Cleveland Water, but it may take them some time to get to that. I know, I got a call from a resident, and the water was leaking for almost a week, but it wasn't a big enough leak to get them there as quickly as they could. Talk to Joe Walker in the service department; but generally, when there is a report with Cleveland Water, they handle those unless it's a major water break. There are a lot of them right now this time of the year.

Mr. Clark - They also take a look at what's going to have to be shut off. They won't shut service off to a school unless it's an emergency. Sometimes that causes a delay until they coordinate with the school or the different building that requires to function and it can't be shut off.

Mr. Jamison - Mr. Clark, are you going to put your microphone on?

Mr. Clark - I did, but maybe I just didn't speak loud enough. Sorry, I just said that the water department also coordinates with the schools or other buildings that might require...sometimes that's what we feel is a significant leak. They are coordinating with the businesses and schools in the area that have a necessity to not have the water turned off.

Mr. Jamison - As Mr. Short indicated, we don't have any direct control over how Cleveland Water schedules those. Clearly, when it's a bigger break, it has more urgency to it. I know a couple years...the last two years on Engle Road in Middleburg Heights, right by their water tower, it broke each winter. Half the road was shut down each time and water gushing. Obviously, that's a priority. Like you said Gordon, this is that time of the year. The freeze/thaw causes all the disruption in the water lines.

Mr. Short - Correct, and we have no say in it. We report it, and then we try to get them there as fast as we can.

Mr. Jamison - Exactly.

# REPORTS OF COUNCIL COMMITTEES:

**ECONOMIC DEVELOPMENT – Mr. Clark:** Thank you President Short, last Monday, January 27, 2025, we had our Strongsville Economic Development Committee meeting at PPG Industries in the Progress Drive Business Park. We began with a presentation from PPG Industries providing an overview of the facility, here in Strongsville, before we toured their manufacturing facility. This is a powder coating facility, so it supports a variety of different industries. One example would be the automotive industry; specifically, Stellantis which is a big customer that is supported out of there. Stellantis being... Chrysler/Fiat - the fourth largest automaker by sales. We had 15 people participate in the tour including our host, Spencer Bradford, who is a resident here in Strongsville. He did, in his opening, comment that both of his kids graduated from Strongsville High School and they are both doing well. It's nice to have business leaders that have a vested interest across all components of our community. About 50 people that work just underneath the manufacturing arm in that facility.

# REPORTS OF COUNCIL COMMITTEES (cont'd):

ECONOMIC DEVELOPMENT - Mr. Clark (cont'd): That does not include numbers associated with administration, business development, and other functions that call the Strongsville base a home office. PPG Industries is very proud of their tenure in that building and here in Strongsville. Before I wrap up, I do want to thank the Plant Manager, Spencer Bradford, Kevin Mathis who leads continuous improvement efforts for Strongsville and other plants, Todd Flynn who leads quality in the Strongsville plant, for the tour, and the information that they shared and keeping us safe. It's evident from the start that there's a big focus, as there is in many manufacturing facilities, on safety and security. That was evident from the moment we walked up to the gate. It was good for all 15 people. As I say, "See together, know together, act together" as we look to do things to make Strongsville an even friendlier place to do business and increase our awareness and understanding of manufacturing. Our next Strongsville Economic Development Committee meeting is going to be on Monday, February 24, 2025 at 2:00 p.m. We have another tour of a Strongsville manufacturing plant. This month we are visiting CCL Design in the Foltz Industrial Parkway. In January, we started with a business in a plant that's been here for many years, and in February, we are seeing a much newer plant right at Foltz Parkway and Drake Road - close to where we have opportunity for future growth. Again, Monday, February 24, 2025 at 2:00 p.m. at the CCL Design headquarters, 17700 Foltz Parkway. That concludes my report, but I will gladly take any guestions.

Mr. Kaminski - I just want to comment that it was a great tour. It was great information to be able to see the work that they are doing, the possible expansions, and conversations there with their available space. Great job organizing that.

**PUBLIC SERVICE AND CONSERVATION – Ms. Roff:** I have one item for Public Service and Conservation. Ordinance No. 2025-012; this is to dispose of and auction off some items that are obsolete that are no longer needed. The recommendation there is to suspend and adopt.

PUBLIC SAFETY & HEALTH – Ms. Kosek: Thank you Mr. Short, for Public Safety and Health we have two ordinances. We have Ordinance No. 2025-013, which would authorize the Mayor to enter into a State of Ohio Administrative Services contract for the purchase of two ambulances for just over \$800,000.00. These would be ordered and would be delivered in several years because of the backlog and the lead time that they need on those. I would ask that we suspend and adopt that. We also have Ordinance No. 2025-014, which is to authorize the auction of two obsolete vehicles. One is a police vehicle - 2015 Ford Fusion, and the other is a service department vehicle - 2009 Ford Taurus. Both have exceeded their useful life for our departments. I would ask that we suspend and adopt so that we can get whatever value we can out of those at auction. That's all I have.

Mr. Short - Thank you, Ms. Kosek. Just for the viewing public, those ambulances are \$800,000.00 total; \$400,000.00 a piece at the state-mandated...negotiated price at the State of Ohio to get the lowest possible price for cities and municipalities in the State of Ohio.

This was placed on first reading at the last meeting. This meeting, we are going to make a motion to amend that. Then, we are going to place it on second reading and refer it to the Planning Commission. Does anybody have any questions?

SCHOOL BOARD - Mr. Carbone: Yes, at the last school board meeting, the board voted to place a hold on a piece of property at 14701 Pearl Road; it's the former Rite Aid. No money was put down or had any transfer for this hold. The district, over the next several months, is going to be conducting a fit plan to see if the current administrative team, in the old Zellers Elementary School's current board office, would be able to fit the structure. I sit on the facilities committee and one of the issues with our facilities...one of the issues with the elementary schools, is the board office. There are structural issues there - two areas are sinking. There are cracks in the walls and those cracks are getting larger. There has to be around a \$1.5 million dollar roof replacement. Right now, because of the structural issues, the company won't even do the roof. There are a lot of issues there - one of the reasons why they were not committed to bringing kids back into that building, like we initially thought would happen. That's why they went forward with the trailers. Stay tuned for more information. I will keep Council updated with progress there. The eighth-grade Dragons team celebrated and recognized a Strongsville resident who turned 110 years old. Emma (Demian) is a resident at Altenheim Senior Living, and the students presented her with 110 cards. Henkel is sponsoring a hands-on workshop for our seventh and eighth grade female students on March 1, 2025, from 9:00 a.m. to 3:00 p.m. called "BuildHer." - It's empowering girls in construction.

SCHOOL BOARD – Mr. Carbone (cont'd): In honor of "Black History Month," tribute portraits have been created by the Strongsville High School "National Art Honor Society" students." SOUTHWEST GENERAL HEALTH SYSTEM - Mr. Short: For the Southwest General Health System, we did not have a board meeting yet this year; however, we do have the monthly update from President and CEO, Bill Young—just a couple of items to touch on there. As we enter the new year, obviously, healthcare still faces challenges in some major trends. Some of those issues that affect the industry, which also affects the Southwest General Health System, are the growth in outpatient care, improving financial performance, the use of artificial intelligence in the healthcare field, growth and robotic surgery innovation, and focusing on the consumer experience. As a whole, the strategic plan, which was approved by the board last December, is to focus on clinical quality and safe care, to focus efforts on ensuring that the Southwest General Health System provides high-quality safe patient care through compliance with key quality and safety metrics - continuing to recruit new employees and retain current employees at the organization, to engage these employees with enhanced annual benefit offerings at the lowest possible cost, to continue to focus on person-centered care - allowing caregivers and medical staff to improve the patient's experience with an emphasis on nursing, communication, responsiveness to patient needs, and physician communication with patients. Obviously, the very key is consumer expansion - both to achieve growth in patient volumes and the operating margins of the system, as well as capital improvements in the capital budget; and looking at things such as artificial intelligence and robotic equipment at the system. That concludes my report, but I will happily take any questions.

#### **AUDIENCE PARTICIPATION:**

Sue Mazzola, 3440 Boston Road, Brunswick, Oh. 44212: Sue Mazzola, 3440 Boston Road, Brunswick. As you know, the fight continues and we have a new bill going in. I'm kind of curious how you are going to go about this one now. Are you going to have the Wizard of Oz over there go in and say he wants another study? I mean, he wanted the study and he got the study. I can't imagine how you are going to be an opponent to this at this point. As of now, you look ridiculous. I would encourage you all to watch the April 17th House and Senate testimony. As I said last time, you go on about your great city, but if you would listen to what the representatives even said up there, you don't look so good. You went above federally prescribed process of getting an interchange, you, as an officer and man of the law, you were okay with that? Ms. Kosek, you who ... I guess you advocate for people. I wonder how your clients would feel knowing that you went above the law to get something. You are advocating for people to lose their homes when the data doesn't show that's feasible. Mr. Kaminski, your grandchildren are beautiful - I'm going to be nice with that. That day I was absolutely going to come up and talk and chose not to. I didn't want to say anything to put you in a position that you would have to go home and explain to your grandchildren why this woman is upset that you're taking her home. I had to do that with my grandchildren. I have signs in my yard, and time has been taken away from them with going and getting signatures and all that stuff, and emails. I had to have that awful conversation with my grandchildren, so I wanted to spare you that. It's not a good look to have to tell your grandchildren that it's for the better good, as the representatives said. Ann, you did say in the beginning that if they were going to widen that road, that you would be against this. I'm not sure what any of your thoughts are. I know you are for it - you've advocated for this. The Mayor is going to retire and he's going to leave you a mess. I think that is why the little switcheroo happened here. I think he is going to retire early, and you're going to become Mayor. Trust me we will...when you run, we will advocate against you. We did pretty good with Tom Patton's opponent. At some point, you've got to stop this. You know it's wrong; and you know the way you did it was wrong. You actually should be embarrassed. I don't know if you're against it and you're all afraid of the big guy - the big powerful mighty Oz. I don't know. At some point, you've got to grow some balls, step up, help the people, and stop this fight. It's not a good look on Strongsville at all. Please watch the testimony because you'll see what I'm saying. You look foolish. We were at the NOACCA meeting and we made you look even more foolish. You're losing the respect. That's the best time for the Mayor to walk out of here; when you've lost the respect from your neighboring communities and from representatives in Ohio. He will walk out on a high note, and then you take the fall.

John Douglas, 3418 Lincoln Avenue, Parma, Ohio: My name is John Douglas. I'm the president of the Strongsville Firefighter's Association, and I actually reside in Parma. The reason that I'm speaking tonight is just to see if you guys are aware, since Mr. Short, you will sit on the board for the Southwest General Health System and report at Southwest General. I know Mayor Perciak is very involved with the trustees and the board at Southwest General. I took an oath of office to protect the residents of this city, and to provide optimal care for the residents of the city. I can't go any further without saying anything that...when we are trying to provide care for the City of Strongsville, and the Strongsville residents are paying taxes to the Southwest General Health Center, that they would turn us away. They would divert us to other hospitals in a time when a resident of Strongsville needs emergency services. This happens multiple times a year.

#### **AUDIENCE PARTICIPATION (cont'd):**

Mr. Douglas (cont'd) - It just recently happened twice over Thanksgiving as well as Christmas break when Southwest General closed their neurology department because they went on vacation. We were no longer to take any patients with stroke-like symptoms to a stroke center at the Southwest General Health Center. I feel that's inappropriate, and I don't know if you guys are aware of this.

Mr. Short - I was not, so I appreciate you bringing that to our attention.

Mr. Douglas - The residents are being diverted away from their hospital. Southwest General is my hospital. I go there, and every one of my doctors are there; it's a great hospital. When you have a resident of this city that needs emergency care and they are being diverted to hospitals that are 10, 15, or 20 minutes away, and these taxpayers are spending their money at this hospital, it's unacceptable. I don't know if you guys are aware of it, but it's been going on for years. I can't do it anymore. I was sworn to protect the residents, and I always will, thank you.

Mr. Short - Thank you, I was unaware of that. I will address that. Thank you for bringing that to our attention.
