SUMMARY OF CAUCUS DISCUSSION AND MINUTES OF THE STRONGSVILLE CITY COUNCIL REGULAR MEETING HELD ON, MONDAY, NOVEMBER 21, 2022.

The Council of the City of Strongsville met in the Caucus Room at the Mike Kalinich Sr. City Council Chamber, 18688 Royalton Road, on **Monday, November 21, 2022 at 7:30 p.m.**

Present: Council Members: James E. Carbone, Gordon C. Short, Joseph C. DeMio, James A. Kaminski, Thomas M. Clark and Kelly A. Kosek. Also Present: Clerk of Council Aimee Pientka. **Administration:** Mayor Thomas P. Perciak, Law Director Neal Jamison and Finance Director Eric Dean.

Absent: Annmarie P. Roff.

Council President, James Carbone, called the caucus to order at 7:39 p.m.

Planning, Zoning & Engineering Committee: Chairman Kaminski advised Ordinance No. 2022-073 is to amend Section 1252.36 of the codified ordinances in connection with prohibited use of shipping and/or storage containers in residential districts. Planning Commission gave this a favorable recommendation. There was a public hearing for this on June 21, 2022. After much discussion during the October 3rd meeting, it was determined to place this on third reading at that time. recommendation was to adopt this legislation this evening. Ordinance No. 2022-152 is an ordinance amending the zoning map of the City of Strongsville adopted by section 1250.03 of Tile Six, Part Twelve of the Codified Ordinances of Strongsville to change the zoning classification of certain real estate located at 21930 Royalton Road, in the City of Strongsville from GI (General Industrial) classification to R1-75, (One Family 75) classification (PPN 392-14-006). It was referred to the Planning Commission at the October 18th Council meeting; and the Planning Commission gave it an unfavorable recommendation at their November 17th meeting. Ms. Kosek asked Mr. Kaminski if he could explain why the commission gave it an unfavorable recommendation and was the vote unanimous. Mr. Kaminski advised the vote was unanimous by the commission. They felt the issues were there was no plan submitted as to why they would want the rezoning; and if it was rezoned and the owner later changed their mind to change it back to residential, it would then become a city ballot issue. Mayor Perciak advised this parcel is right next to Vitalia senior residences. He was hoping they would buy the parcel, but they would not. The recommendation was to place this on second reading and set for a public hearing on January 3, 2023.

Finance Committee: Chairwoman Kosek advised Ordinance Nos. 2022-159 through 2022-162 are TIFs (tax increment financing) ordinances for Autozone, CCL, Litehouse and Schaeffler respectively. Ordinance No. 2022-161 will be amended to reflect Exhibit B, where we're including improvements on Prospect Road. These will all be placed on second reading this evening. Suspension and adoption was recommended for Ordinance No. 2022-168; an appropriations ordinance for the annual expenses of the city. Ms. Kosek advised they all received a memo today from Mr. Dean regarding the appropriations. Suspension and adoption was recommended for Ordinance No. 2022-169; an ordinance authorizing the director of finance to enter into an agreement with Travelers Companies, as a carrier through the Fedeli Group, to purchase property-casualty and related insurance coverages. Ms. Kosek advised this needs to pass tonight because the insurance expires at the end of the month. This is without public bidding so all 7 votes of Council are needed for this legislation to pass. Ms. Kosek advised Resolution No. 2022-170 is to request from the Fiscal Officer of Cuyahoga county to advance certain funds, both general and operating and special assessments, to the City of Strongsville. Suspension and adoption was recommended for this legislation.

<u>Public Safety & Health Committee:</u> Chairman Kaminski recommended suspension and adoption for Ordinance No. 2022-171; an ordinance authorizing the Mayor to enter into a contract for the purchase of two new Stryker power pro cots and two new Stryker power load systems. Mr. Kaminski advised these will come in mid to late summer. Also, this ties in with the two ambulances purchased earlier. Mr. Clark asked if we have multiple on order right now. Mr. Kaminski advised no; it was just these. The is without public bidding so all 7 votes of Council are needed to pass this legislation.

<u>Public Service & Conservation Committee</u>: Chairman DeMio recommended suspension and adoption for Ordinance No. 2022-172; authorizing the purchase of a vehicle and equipment maintenance repair parts with related items and services for 2022; as well as authorizing future additional purchases of such vehicle and equipment maintenance repair parts with related emergency items, as needed by the service department. The contract is with Napa Auto Parts in an amount not to exceed \$325,000.00. This is without public bidding so all 7 votes of Council are needed for this legislation to pass. Suspension and adoption was also recommended for Ordinance No. 2022-173; an ordinance authorizing the Mayor to enter into a contract for the purchase of a 32-passenger bus to be used by various city departments. The contract is with Myers Equipment Corporation in a total amount not to exceed \$191,575,42.

Recreation and Community Services Committee: Mr. Carbone recommended suspension and adoption for Ordinance Nos. 2022-174 and 2022-175; ordinances authorizing the Mayor to enter into agreements to purchase electricity for municipal facilities through Dynegy Energy Services East, LLC, through Kinect Energy, Inc.; and to purchase natural gas for municipal facilities through United Energy Trading, LLC, through Kinect Energy, Inc. respectively. Mr Dean advised we looked at the electric and gas supply as the contract for electric was set to expire. The electric was at a variable rate; and the city spends close to a million dollars on electricity. These are 5-year contracts. Mr. Dean believes as the electric rates are going up and this will save the city money going forward. Both are without public bidding and need all 7 votes of Council for them to pass this evening. Suspension and adoption was recommended for Ordinance No. 2022-176; an ordinance authorizing the Mayor to enter into a contract for owner's representative professional services in connection with the Town Center Enhancement and Walkability Initiative project. The contract is RFC Contracting, LLC for a 3-year period, in the amount of \$161,000.00. Suspension and adoption was recommended for Resolution No. 2022-177; a resolution to advertise for bids for the purchase of youth sports wearing apparel for use by the recreation department during 2023.

Ms. Roff – Thank you guys, have a good Thanksgiving. Just a brief announcement, we are going to do the recreation center committee meeting before our first meeting in December, on December 5th. That will be at...Bryan is willing to take anybody, 1 or 2 at a time, if you give him a call through the recreation center; just for everybody to get an idea of where things are at and any updates he wants to give you before the meeting. That way, we are falling within the guidelines of the Sunshine Law; the time will be announced.

Mr. Carbone – Thank you, we hope you feel better and thank you again for coming in.

APPOINTMENTS, CONFIRMATIONS, AWARDS AND RECOGNITIONS:

REPORTS OF COUNCIL COMMITTEES:

SCHOOL BOARD - Mr. Clark: Thank you Council President Carbone, there was a Strongsville City School board meeting on Thursday, November 10, 2022; the district remains financially favorable to budget. The Strongsville City Schools fiscal year 2023...5-year forecast is due to the state on November 30, 2022 and will be voted on at the next meeting. Fiscal year 2023 revenue over expenses of about \$6.2 million, 2024 revenue over expenses of about \$3.1 million and then in 2025 expenses exceed revenue by about \$3.2 million. That continues to increase year over year as the levies expire as we look ahead of where we stand right now. There was a memorandum of understanding during that meeting as many schools need bus drivers; the memorandum of understanding was referencing incentives. Good to see that our district is trying to stay ahead of it and keep our kids safe with good bus drivers; there is \$150.00 of fees that can get covered to get qualified. If you are interested in being a bus driver for our schools, please reach out, we need to make sure we have those and there are additional incentives to keep them onboard. Not from the meeting, but shared with our superintendent since, and given the weather...sticking onto the buses; it's freezing out. The superintendent put a recent reminder out...yellow means that the school bus is about to stop and a flashing red light means that our students are getting on and off the bus. Vehicles...traffic needs to stop in accordance with the law; just a reminder there. Another thing going on right now, the schools are going through their vision building exercise, and there's an outside party that's helping facilitate that; there's been numerous opportunities. I was...a couple of weeks ago, I reported at the board meeting where they collected the voice of the board if you will. They are collecting the voice of the administration, the voice of the students, the voice of the parents and the voice of the community. The Mayor and I were involved in an exercise earlier this week at the school board buildings; there has been lots of opportunities to go through a SWOT exercise with this outside party. There are surveys out to parents right now as well. Last but certainly not least, I want to congratulate the Strongsville girls' soccer team who finished second in the state; an exciting trip down there. You know...there's only one team that is happy at the end of the season, but I think they have a lot to be happy...to be runners up in the state. What a great way for them to finish the year. That concludes my school board liaison report, but I'll take any questions.

BUILDING AND UTILITIES - Mr. Clark:

(No report)

SOUTHWEST GENERAL HEALTH SYSTEM - Mr. Short: Thank you Mr. Carbone, we have not had a board meeting yet for Southwest General. The next one...a system wide and a joint board meeting for the hospital and the system will be December 1, 2022; I will have more details then. Quick couple of updates in terms of Covid-19, the hospital is not seeing very many patients...about 10 to 15 per day; very few are requiring critical care. I probably will wind down my updates on that subject; however, to note that the Southwest General Hospital will not be giving the latest Covid-19 booster. The hospital encourages people to use their local pharmacy and make an appointment there for the most recent Covid-19 booster. A couple of notes on things that are happening in terms of expansion at the hospital system. As patient volume continues to grow, and was higher again in October than previous budget numbers, we are seeing people going back and using the facilities. They are seeing their doctors, and having procedures done at the hospital and the system, which is great. In response to that, the system has committed about \$10.3 million of capital improvements in the organization so far just this year. Most of that is for large facility infrastructure projects such as CT scanner replacements, orthopedic surgery replacements, surgical booms, etc.; those types of equipment especially. Also, like ultrasound equipment that is needed at the new Cosgrove Family Maternity Center. Couple of things that are going to be expanding at the system; as we know, St. Vincent Charity Medical Center is closing down in Downtown Cleveland. The Bariatric Surgery Center, which was nationally recognized there, will be transitioning to Southwest General this month; those patients will be seen.

REPORTS OF COUNCIL COMMITTEES (cont'd):

SOUTHWEST GENERAL HEALTH SYSTEM – Mr. Short (cont'd): Their surgery will be performed at Southwest General as well as a collaboration with University Hospitals providing expanded cardiac surgery services at Southwest General beginning December 1, 2022. They continue to expand, and bring world class healthcare right here in our backyard. On that note, some highlights and some awards and recognitions that the system continues to receive both literally and nationally; I will run down a few of those quickly. The centers for Medicare and Medicaid services recognize Southwest General again, as a five-star quality rated hospital based on patient quality outcomes. The community emergency medical service (EMS) providers under Southwest General's medical direction, has achieved a Gold Plus for 2022 Mission Recognition from The American Heart Association for commitment to high quality care. The Berea Chamber of Commerce recognized the system with it's 2022 Legacy Award; the award is presented to a long-standing Berea business that has made a significant and positive impact on the community. Again, in regards to the...with the closing of St. Vincent Charity Medical Center, those employees are being interviewed and hired at Southwest General as well; not only for the Bariatric Center, but for other positions as well. As we know, even hospitals are facing employee shortages and so....

Mayor Perciak – We actually had an employee fair for that.

Mr. Short – Yes, so we are finding good quality people there to fill the positions at Southwest General. That concludes my report for this meeting. I will have more after our system joint board meeting on December 1, 2022, but I will happily take any questions.

ECONOMIC DEVELOPMENT – Mr. Short: Next Monday, November 28, 2022 at 7 p.m. right here in these Chambers, the Economic Development Committee will meet for our last meeting of the year; which will be highlighted by our Economic Development Director, Brent Painter. He will be giving us a summary of 2022...what has happened in the city in terms of economic developments, and what to look ahead for in 2023. We will send a notice tomorrow to our board members and obviously besides the Committee, the rest of Council is welcome to attend that at 7 p.m., next Monday the 28th of November right back here in Council Chambers. That concludes my report, but I will happily take any questions.

FINANCE - Ms. Kosek: We have a number of ordinances tonight in Finance, and I will take the first four which will be second readings. Ordinance Nos. 2022-159, 2022-160, 2022-161 and 2022-162; those are Autozone, CCL, Litehouse and Schaeffler to TIF those new economic development properties. Ordinance No. 2022-161, when we spoke about that at the last Council meeting, we raised the possibility of Prospect Road being included as part of what the TIF money could be used for. We are going to move to amend that tonight to include improvements on Prospect Road. We also have...excuse me, so we will do that amendment and then those all go on second reading. We also have Ordinance No. 2022-168; which is our appropriations ordinance, we all should have received a memorandum from our finance director explaining those changes. They net out to about \$146,440.00 and net change compared to the prior ordinance; all of those details are in that memo. We have Ordinance No. 2022-169, but that was one that we had already voted on which was just to change our... excuse me, to continue our insurance. Then, we have Resolution No. 2022-170; which is to ask the county to advance our tax collections on a monthly basis as opposed to a bi-annually basis. Those last two, I would ask that we suspend and adopt. If anybody has any questions, I will be happy to answer those; otherwise, I will close the committee. Thank you, Jim.

REPORTS OF COUNCIL COMMITTEES (cont'd):

PUBLIC SERVICE AND CONSERVATION – Mr. DeMio: Thank you, Ordinance No. 2022-173 is a 32-passanger bus....it comes out to \$191,575.42; it will be used for various departments. We would like to suspend and adopt that please. That's all I have, Jim.

PLANNING, ZONING AND ENGINEERING – Mr. Kaminski: Okay, for Planning, Zoning and Engineering we have Ordinance No. 2022-073; which is to prohibit the use of shipping and storage containers in residential districts; the recommendation is to adopt this evening. Ordinance No. 2022-152 is to change zoning classification of 21930 Royalton Road from GI (General Industrial) classification to R1-75 (one family 75) classification. It was received as unfavorable recognition from the Planning Commission and that is on second reading this evening. That concludes Planning, Zoning and Engineering.... I will move on to Public Safety and Health.

Ms. Pientka – Mr. Kaminski...I'm sorry, may I just clarify something? We are also setting a public hearing on that rezoning for January 3, 2023, thank you.

PUBLIC SAFETY AND HEALTH – Mr. Kaminski: We did already vote on this, this evening. It was Ordinance No. 2022-171; which authorized the Mayor to enter a contract for the purchase of two Stryker Power Pro Cots and two power load systems used for the fire department. Again, that was already suspended and adopted this evening. That concludes my report for Public Safety, I will be...oh I'm sorry, I am going to hand it over to Gordon...Gordon had something for Public Safety and Health.

Mr. Short – Really quick for Public Safety and Health, today I participated in...the fire department allows residents at no cost to have first aid emergency training for CPR for both adults and infants choking and also the use of an AED (Automatic External Defibrillator). That was probably the best three hours of my life I spent if you ever need to save somebody's life. I know I spoke to the firemen afterwards, there will be a schedule in 2023 coming out for that, and hopefully there will be more dates to make it more accessible to the public. There is no cost again to attend that. There is a fee if you actually want a certification from the American Heart Association; it's twenty dollars. Again, I will let you know. We will post some more, but again, I think it is a phenomenal service offered to our residents from our fire department. If you need...I hope you never need it, but it is good to have those skills and those lessons if you ever have a life-saving emergency.

RECREATION AND COMMUNITY SERVICES - Ms. Roff:

Mr. Carbone - I will do this for Ms. Roff. We have Ordinance No. 2022-176, this is for an owner's representative for The Town Center Enhancement Walkability Initiative project; the recommendation is going to be to suspend and adopt. Then we have Resolution No. 2022-177, this is to advertise for bids for the purchase of youth sports wearing apparel for the recreation department for the year 2023; the recommendation is going to be to suspend and adopt. I will just reiterate what Ann said in caucus, that there will be a Recreation Committee Meeting on December 5, 2022 prior to our Council Meeting; we will have a time for that in the next week. Also, any of Council, if we have any questions for Bryan Bogre, the director of the recreation center, please have those questions for them prior to the meeting, so we can have good collaboration on that. Also, if anybody would like a tour of the recreation center by Mr. Bogre, just make contact with him, and then you can set up that tour.

REPORTS OF COUNCIL COMMITTEES (cont'd):

COMMUNICATIONS AND TECHNOLOGY - Mr. Carbone: We have no legislation this evening on the agenda, I just wanted to wish everybody a very Happy Thanksgiving; just getting an opportunity with your family and your friends. A lot of love...a lot of time together, is much needed in times like this. Also, if you have a little bit of time over the weekend, please visit our Center of Town. I know the Mayor is probably going to talk about this, but it's absolutely amazing again this year. We thank all the sponsors, we thank all the people for coming out last night in the cold. Again, for myself and all of Council, we wish you a very Happy Thanksgiving.

MAYOR PERCIAK: Thank you Mr. President, good evening everyone. Just to pick up where Council President, Jim Carbone left off. I really want to thank all the sponsors who helped make last night possible. The list just goes on and on from sponsors; from the fireworks, down to \$250.00...from \$7,000.00 all the way down; we could not have had last night without their help and their sponsorship. I think about those who never got their justice, who got to live authentically; felt accepted and loved anybody they wanted to unconditionally; they won't get to be at that table. I want to wish you all a Happy Thanksgiving. I'm not meant to share this with any animosity, it's just something I have been reflecting on for quite some time, and I really want this to be thought through and something to be done in the right way, thank you.

I just want to say I'm on Pineview Circle, but my drive is on Pinewood where they did all the streets and stuff.
