**A RESOLUTION APPROVING AN EXTENSION OF TIME FOR PLANNING COMMISSION TO SUBMIT ITS REPORT AND RECOMMENDATION ON ORDINANCE NO. 2014-085, AND DECLARING AN EMERGENCY.**

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA, AND STATE OF OHIO:

**Section 1.** That this Council finds and determines that a request has been made and good cause has been shown for an extension of time for Planning Commission to submit its report and recommendation on Ordinance No. 2014-085.

**Section 2.** That the time for Planning Commission to submit its report and recommendation on Ordinance No. 2014-085 be and is hereby extended ninety (90) days to October 2, 2014.

**Section 3.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council; and that all deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

**Section 4.** That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the City, and for the further reason that an immediate extension of time is necessary in order to provide for the orderly administration and conduct of the business of the Planning Commission, and to protect the rights of the citizens and applicants affected by the aforesaid legislation. Therefore, provided this Resolution receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.
