AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT FOR REMOVAL AND REPLACEMENT OF ASPHALT PAVEMENT AND INSTALLATION OF NEW 448 ASPHALT COURSES ON VARIOUS STREETS IN THE CITY OF STRONGSVILLE IN CONNECTION WITH THE ASPHALT STREET PROGRAM FOR 2014, AND DECLARING AN EMERGENCY.

WHEREAS, the City has advertised and received bids for removal and replacement of asphalt pavement and installation of new 448 asphalt courses on various streets in the City of Strongsville in connection with the Asphalt Street Program for 2014; and

WHEREAS, Council is desirous of proceeding to award and enter into a contract for such improvements;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

- **Section 1.** That this Council hereby finds and determines that the bid submitted by **KARVO PAVING COMPANY** for removal and replacement of asphalt pavement and installation of new 448 asphalt courses on various streets in the City of Strongsville in connection with the Asphalt Street Program for 2014, meets the specifications on file in the office of the City Engineer; is in compliance with the applicable requirements for bids and contracts established by the laws of the City and the State; and is the lowest and best bid for the proposed contract. All other bids for this contract are hereby rejected.
- **Section 2.** That the Mayor be and is hereby authorized and directed to enter into a contract with the aforesaid lowest and best bidder in the amount of \$927,272.10 for removal and replacement of asphalt pavement and installation of new 448 asphalt courses on various streets in the City of Strongsville in connection with the Asphalt Street Program for 2014, in a form approved by the Law Director.
- **Section 3.** That the funds for the purposes of this Ordinance have been appropriated and shall be paid from the General Capital Improvement Fund.
- **Section 4.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open

meeting of this Council; and that all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 5. That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the City, and for the further reason that it is immediately necessary to authorize execution of said contract in order to improve various streets in the City, ensure safe travel for the residents and the public, and to conserve public funds. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.
