## **ORDINANCE NO. 2015 –** <u>016</u>

**RATIFYING** AND **AUTHORIZING** AN ORDINANCE **DEPARTMENT** OHIO **PARTICIPATION** IN ADMINISTRATIVE SERVICES CONTRACTS FOR THE PRINTER, SCANNER, PURCHASE OF COMPUTER, HARDWARE, AND SOFTWARE **NETWORKING** SUPPLIES, IN SUPPORT OF THE CITY'S TECHNOLOGY NEEDS, BY THE DIRECTOR OF COMMUNICATION & TECHNOLOGY THROUGH CDW GOVERNMENT, LLC; MAYOR TO **ENTER** INTO **AUTHORIZING** THE AGREEMENTS IN CONNECTION THEREWITH; AND **DECLARING AN EMERGENCY.** 

WHEREAS, Ohio Revised Code Section 5513.01(B) provides the opportunity for counties, townships and municipal corporations to participate in contracts of the Ohio Department of Administrative Services for the purchase of machinery, materials, supplies or other articles; and

WHEREAS, the Director of Communication & Technology recommends purchase of various computer, printer, scanner, networking hardware, software and supplies from CDW Government, LLC, under Contract No. 534334, Index No. STS-033, for use by various departments of the City during the first half of 2015.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1. That this Council hereby authorizes the Mayor to request authority in the name of the City of Strongsville to participate in the Ohio Department of Administrative Services contracts for the purchase of various computer, printer, scanner, networking hardware, software and supplies, in support of the City's technology needs, by the Director of Communication & Technology through CDW GOVERNMENT, LLC for use by various departments of the City in a total amount not to exceed \$175,000.00 from January 1, 2015 through June 30, 2015, which the Department has entered into pursuant to Revised Code Section 5513.01(B).

**Section 2.** That the City of Strongsville hereby agrees to be bound by the terms and conditions prescribed by the Director of Administrative Services for such purchases and to directly pay the vendor, under each such contract of the Ohio Department of Administrative Services in which the City participates for items it receives pursuant to the contract.

- **Section 3.** That any purchases made to date are ratified; and that this Council hereby authorizes the Mayor and Director of Finance to enter into and execute such agreements and documents necessary for participation in the Ohio Department of Administrative Services Cooperative Purchasing Program.
- **Section 4.** That the funds for the purposes of this Ordinance have been appropriated and shall be paid from the General Fund.
- **Section 5.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council; and that all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.
- **Section 6.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare, and for the further reason that it is immediately necessary to participate in the purchase of such computer, printer, scanner, networking hardware, software and supplies, in order to maintain continuity in technology systems, and in the operation of various departments of the City, and to conserve public funds. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise from and after the earliest period allowed by law.
