A RESOLUTION GRANTING PERMISSION TO REPURCHASE CERTAIN CERTIFICATES FOR BURIAL RIGHTS IN THE STRONGSVILLE MUNICIPAL CEMETERY. [Rae-Vraja]

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA, AND STATE OF OHIO:

Section 1. That pursuant to Codified Ordinance Section 1060.09, and due to changes occurring in the wishes of certificate holders for family burial arrangements, this Council hereby authorizes the repurchase of certificates for burial rights in the Strongsville Municipal Cemetery for Graves F and J, in Lot 96 of Section F and Grave I, in Lot 97 of Section F, all from Mildred Rae and Karen Vraja, by the City of Strongsville at the same prices that were originally paid therefor.

Section 2. That the funds for the repurchase of said certificates have been appropriated and shall be paid from the General Fund.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council; and that all deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. That this Resolution shall take effect and be in force from and after its approval by the Mayor.
