ORDINANCE NO. 2015 – 103

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 2015-015 TO EXTEND THE TERM OF THE CONTRACT UNDER THE UNITED STATES GENERAL SERVICES ADMINISTRATION AUTHORIZING THE PURCHASE OF SERVICES AND SUPPORT FOR VIDEO PROCESSING AND SURVEILLANCE, FORENSIC AND FRAUD PREVENTION, DATA NETWORK ENGINEERING, AND COMPUTER HARDWARE AND SOFTWARE MAINTENANCE FOR USE BY VARIOUS DEPARTMENTS OF THE CITY, AND DECLARING AN EMERGENCY.

WHEREAS, by and through Ordinance No. 2015-015, Council authorized the Mayor to request authority in the name of the City of Strongsville to participate in the United States General Services Administration (GSA) contracts for the purchase of various services and support for video processing and surveillance, forensic and fraud prevention, data network engineering, and computer hardware and software maintenance through Sems & Associates Limited, for use by various departments of the City in a total amount not to exceed \$150,000.00, and for a term ending May 10, 2015, which the Department entered into pursuant to the United States General Services Administrative Cooperative Purchasing Program; and

WHEREAS, the Director of Communication & Technology now has advised this Council that the GSA contract for Sems & Associates Limited, under Contract No. GS-35F-0434W, has been renewed through 2020, enabling the City to complete the existing contract retroactive to May 10, 2015 through December 31, 2015; and

WHEREAS, this Council, therefore, is desirous of amending Section 1 of Ordinance No. 2015-015, in order to extend the time period for such services, support and maintenance of the City's technology needs with Sems & Associates Limited through December 31, 2015.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1. That Section 1 of Ordinance No. 2015-015 be and is hereby amended to read in its entirety as follows:

“Section 1. That the Mayor be and is hereby authorized and directed to request authority in the name of the City of Strongsville to participate in the United States General Services Administration Federal Supply Schedule, Information Technology contracts for the purchase of various services and support for video processing and surveillance, forensic and fraud prevention, data network engineering, and computer

hardware and software maintenance from **SEMS & ASSOCIATES LIMITED** for use by various departments of the City in amounts not to exceed a total of \$150,000.00 from January 1, 2015 through ~~May~~ **December 31**, 2015, based upon the hourly pricing rates set forth in the price list for such contract, which the General Services Administration has entered into pursuant to law, and that is on file with the City's Director of Communication and Technology."

Section 2. That any purchases made since May 10, 2015 are hereby ratified.

Section 3. That the funds for the purposes of this Ordinance have been appropriated and shall be paid from the General Fund.

Section 4. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council; and that all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 5. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare, and for the further reason that it is immediately necessary to extend the term of the existing contract for services, support and maintenance of the City's technology needs, for use by the various departments of the City in order to maintain continuity and efficiency in the operation of the Department of Communication and Technology, other City Departments, and to conserve public funds. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise from and after the earliest period allowed by law.
