ORDINANCE NO. 2015 – 104

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 2015-016 TO EXTEND THE TERM OF THE CONTRACT WITH CDW GOVERNMENT, LLC UNDER THE OHIO DEPARTMENT OF ADMINISTRATIVE SERVICES CONTRACTS AUTHORIZING THE PURCHASE OF COMPUTER, PRINTER, SCANNER, NETWORKING HARDWARE, SOFTWARE AND SUPPLIES, IN SUPPORT OF THE CITY'S TECHNOLOGY NEEDS, AND DECLARING AN EMERGENCY.

WHEREAS, by and through Ordinance No. 2015-016, Council authorized the Mayor to request authority in the name of the City of Strongsville to participate in the Ohio Department of Administrative Services contracts for the purchase of computer, printer, scanner, networking hardware, software and supplies, in support of the City's technology needs through CDW Government, LLC, for use by various departments of the City in a total amount not to exceed \$175,000.00, and for a term ending June 30, 2015, which the Department entered into pursuant to Revised Code Section 5513.01(B); and

WHEREAS, the Director of Communication & Technology now has advised this Council that the Ohio Department of Administrative Services contract for CDW Government, LLC, under Schedule No. 534334, Index No. STS-033, has been renewed to January, 2019, enabling the City to complete the existing contract through December 31, 2015; and

WHEREAS, this Council, therefore, is desirous of amending Section 1 of Ordinance No. 2015-016, in order to extend the time period for such purchases of various computer, printer, scanner, networking hardware, software and supplies, in support of the City's technology needs, by the Director of Communication & Technology, with CDW Government, LLC through December 31, 2015.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1. That Section 1 of Ordinance No. 2015-016 be and is hereby amended to read in its entirety as follows:

“Section 1. That this Council hereby authorizes the Mayor to request authority in the name of the City of Strongsville to participate in the Ohio Department of Administrative Services contracts for the purchase of various computer, printer, scanner, networking hardware, software and supplies, in support of the City's technology needs, by the

Director of Communication & Technology through **CDW GOVERNMENT, LLC** for use by various departments of the City in a total amount not to exceed \$175,000.00 from January 1, 2015 through ~~June 30~~**December 31**, 2015, which the Department has entered into pursuant to Revised Code Section 5513.01(B)."

Section 2. That the funds for the purposes of this Ordinance have been appropriated and shall be paid from the General Fund.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council; and that all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare, and for the further reason that it is immediately necessary to extend the term of the existing contract for the purchase of various computer, printer, scanner, networking hardware and supplies, in order to maintain continuity and efficiency in the operation of City Departments, and to conserve public funds. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise from and after the earliest period allowed by law.
