A RESOLUTION AUTHORIZING THE MAYOR TO ADVERTISE A REQUEST FOR PROPOSALS FOR PROFESSIONAL ADVERTISING AGENCY, MARKETING, AND RELATED CONSULTING SERVICES, IN CONNECTION WITH THE CITY'S PROMOTION OF ITS RECREATION AND SENIOR DEPARTMENT PROGRAMS, EVENTS, AND PROGRAM BULLETIN.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1. That the Mayor be and is hereby authorized to advertise a request for proposals for professional advertising agency, marketing, and related consulting services in connection with the City's promotion of its Recreation and Senior Department programs, events and program bulletin, in accordance with the documents on file in the office of the City of Strongsville Director of Recreation & Senior Services, which are, in all respects, hereby approved.

Section 2. That the funds for the purposes of this Resolution have been appropriated and shall be paid from the Multi-Purpose Complex Fund.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council; and that all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. That this Resolution shall take effect and be in force immediately upon its passage and approval by the Mayor.
