ORDINANCE NO. 2015 – 217

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A STATE OF OHIO ADMINISTRATIVE SERVICES CONTRACT FOR THE PURCHASE OF ONE (1) JOHN DEERE 4044R COMPACT UTILITY TRACTOR AND APPURTENANCES, FOR USE BY THE DEPARTMENT OF PUBLIC SERVICE OF THE CITY, WITH THE SALE, TRADE-IN AND CREDIT FOR ONE (1) EXISTING OBSOLETE JOHN DEERE 4044R COMPACT UTILITY TRACTOR, CONSISTENT WITH TERMS SET BY A PRIOR ROLL AGREEMENT, AND DECLARING AN EMERGENCY.

WHEREAS, Ohio Revised Code Section 5513.01(B) provides the opportunity for counties, townships and municipal corporations to participate in contracts of the Ohio Department of Administrative Services for the purchase of machinery, materials, supplies or other articles; and

WHEREAS, this Council wishes to take advantage of that opportunity to purchase one (1) John Deere 4044R Compact Utility Tractor, with appurtenances, (Schedule No. 800276, Index No. STS515) for use by the Department of Public Service of the City; and

WHEREAS, through Ordinance No. 2014-221, this Council previously authorized the Mayor and Department of Public Service to enter into a Roll Agreement with John Deere & Company through its authorized dealer, Polen Implement, Inc., which provides the opportunity for governmental agencies to upgrade tractors on a yearly basis with special pricing through a Roll Agreement program, and includes trade-in of the existing comparable John Deere tractor; and

WHEREAS, therefore, the Department of Public Service wishes to once again utilize such Roll Agreement program and trade-in one (1) John Deere 4044R Compact Utility Tractor that is obsolete and eligible for trade-in; and

WHEREAS, pursuant to Article IV, §3(e) of the City Charter, the Director of Finance is authorized to sell and trade-in obsolete or surplus equipment in such manner as Council may by ordinance authorize; and

WHEREAS, this Council is desirous of having the Director of Finance sell and trade-in the existing obsolete John Deere 4044R Compact Utility Tractor, and have the selling price credited against the purchase price of the new, upgraded John Deere 4044R Utility Tractor, with appurtenances.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1. That this Council finds that the Service Department of the City of Strongsville has one (1) John Deere 4044R Compact Utility Tractor, which is obsolete, and therefore, is no longer needed for any municipal purpose, and further finds that it will be in the best interests of the City to sell and trade-in such equipment, and have the selling price applied as a credit against the purchase of a new, upgraded John Deere 4044R Compact Utility Tractor with appurtenances.

Section 2. That the Mayor accordingly be and is hereby authorized and directed to request authority in the name of the City of Strongsville to participate in an Ohio Department of Administrative Services contract with **JOHN DEERE & COMPANY, through POLEN IMPLEMENT, INC.**, its authorized dealer, for the purchase of one (1) John Deere 4044R Compact Utility Tractor, with appurtenances, in the amount of \$26,017.16, and for the sale and trade-in of one (1) existing John Deere 4044R Compact Utility Tractor for the amount of \$24,517.16, pursuant to the aforementioned Roll Agreement, and providing that the sale price be credited towards the purchase price of the new John Deere 4044R Compact Utility Tractor, with appurtenances, resulting in a total net and final contract price for the new and upgraded equipment in an amount not to exceed \$1,500.00, all as reflected on the invoice attached hereto as Exhibit A and incorporated herein.

Section 3. That the City of Strongsville hereby agrees to be bound by the terms and conditions prescribed by the Director of Administrative Services for such purchases, and to directly pay the vendor, under each such contract of the Ohio Department of Administrative Services in which the City participates for items it receives pursuant to the contract.

Section 4. That the Mayor and Director of Finance be and are hereby authorized to enter into and execute such agreements and documents as may be necessary to participate in the Ohio Department of Administrative Services Cooperative Purchasing Program and prior Roll Agreement with John Deere & Company, through its authorized dealer, Polen Implement, Inc.

Section 5. That the funds for the purposes of said contract have been appropriated and shall be paid from the General Fund.

Section 6. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council; and that all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 7. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare of the City, and for the further reason that it is immediately necessary to enter into said contract to provide for the continuity of services and efficient operation of the City of Strongsville Department of Public Service, to provide updated equipment, and to conserve public funds. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.
