ORDINANCE NO. 2015 – 218

AN ORDINANCE AUTHORIZING THE CITY, THROUGH THE MAYOR AND DIRECTOR OF FINANCE, TO ALLOCATE AND APPROPRIATE UP TO TWENTY-FIVE THOUSAND DOLLARS FOR VARIOUS EXPENDITURES FOR PUBLIC PURPOSES FOR THE 2016 STRONGSVILLE BICENTENNIAL CELEBRATION.

WHEREAS, in February, 2016, the City of Strongsville will be celebrating its Bicentennial birthday; and

WHEREAS, in addition to private donations and contributions from various community organizations and/or other sources supporting such celebration, it will be necessary and appropriate to allocate and appropriate up to Twenty-Five Thousand Dollars (\$25,000.00) in City funds for this public purpose, and to support expenditures for such things as advertising, signage, artwork, street banners, staging, additional programming and refreshments, and related items necessary for the day of the public celebration; and

WHEREAS, said funds shall be spent only in accordance with the Codified Ordinances of the City of Strongsville.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1. That Council hereby authorizes the Mayor and Director of Finance to expend an amount up to Twenty-Five Thousand Dollars (\$25,000.00) for the Strongsville Bicentennial Celebration scheduled for February, 2016, and further provided that said expenditures shall be in accordance with the Codified Ordinances of the City of Strongsville.

Section 2. That the funds for the purposes of this Ordinance have been appropriated and shall be paid from the General Fund.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council; and that all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.
