### SUMMARY OF CAUCUS DISCUSSION AND MINUTES OF THE STRONGSVILLE CITY COUNCIL REGULAR MEETING HELD ON APRIL 20, 2015.

The Council of the City of Strongsville met in the Caucus Room at the Mike Kalinich Sr. City Council Chamber, 18688 Royalton Road, on **Monday**, *April 20*, *2015 at 7:20 p.m.*

Council President Daymut called the caucus to order at 7:21 p.m.

The following Council Committees met to review legislation on the agenda:

Planning, Zoning and Engineering Committee: Mr. Malonev advised Ordinance No. 2015-021 pertains to the rezoning of property located on Royalton Road (PPN 398-29-019) for a proposed Dunkin Donuts. This has been through first reading and received favorable recommendation from Planning Commission. There were no objections during the public hearing. The recommendation will be to adopt this legislation. Ordinance No. 2015-057 will be placed on second reading and set for a public hearing on June 1, 2015. This is to rezone the vacant property located at Westwood Drive (PPN 396-10-016) from GB (General Business) classification to R-RS (Restaurant-Recreation Services) classification. This is for a proposed Mitchell's Ice Cream. Mr. DeMio asked Mr. Maloney to advise Council about the parking area this place will have. Suspension and adoption was recommended for Ordinance No. 2015-074; an ordinance to authorize the Mayor to enter into a contract for improvements to various streets in the City of Strongsville in connection with the Pavement Reconstruction Program for 2015-Phase II. This is for concrete streets. The contract was awarded to Fabrizi Trucking and Paving Co., Inc. for \$1,324,950.00. Ordinance No. 2015-075 is to authorize the Mayor to enter into a contract for removal and replacement of asphalt pavement on various streets in the City of Strongsville in connection with the Asphalt Street Program for 2015. The contract was awarded to Chagrin Valley Paving, Inc. in the amount of \$626,342.60. The recommendation was to suspend and adopt. Suspension and adoption was also recommended for Resolution 2015-076; a resolution authorizing the Mayor to advertise for bids for the 2015 West 130<sup>th</sup> Pump Station Project.

<u>Public Service and Conservation Committee:</u> Chairman Carbone recommended suspension and adoption for Resolution Nos. 2015-077, 2015-078, 2015-079 and 2015-080. These are all resolutions granting permission to repurchase certain certificates for burial right in the Strongsville Municipal Cemetery (Rae-Kucinich, Rae-Vraja, Rae-Vanderwyst, Rae-Miciunas). In addition, there will be two motions on the floor for wishes for interments. Mr. DeMio asked about the cemetery fence and status. Mr. Walker stated they are working on it.

<u>Finance Committee:</u> Mr. Dooner recommended Resolution No. 2015-081 be placed on first reading. This is to adopt the alternative tax budget information for the City of Strongsville for fiscal year 2016.

<u>Building and Utilities Committee:</u> Mr. Schonhut recommended suspension and adoption for Ordinance Nos. 2015-082, 2015-083, 2015-084 and 2015-085. These are ordinances authorizing the Mayor to enter into independent contractor agreements with Anthony Bumbalis, John B. Kornick, Julie Sipka and Herschman Architects, Inc. for professional architectural services in connection with the Building Code of the City of Strongsville and the Ohio Building Code. All seven votes of Council are required for these ordinances to pass.

<u>Economic Development Committee:</u> Mr. Daymut stated the next committee meeting will be Monday, April 27, 2015 at 7:00 p.m.

Committee of the Whole: Mr. Daymut briefly reviewed the agenda. There will be a ceremonial swearing in of one police officer and the swearing in of five firefighter/paramedics. He advised that additional documentation has come forth from the County pertaining to Resolution No. 2015-073, a resolution approving the application of Emil S. Karim to place farmland in an agricultural district. This documentation provides evidence that this parcel is being used for agricultural use. In light of this, Council will amend the agenda to reconsider this resolution, then suspend and adopt. Mr. Maloney commented that the documentation shows they are farming hay on the property. Mr. Daymut stated that the burden to determine if this land is being used for agricultural use falls to the county. Also on the agenda are two liquor permits. There are no objections to WJF Investment Corp., 8952 Pearl Road, but there will be a conditional objection to Bella Sports Pub, 14395 Pearl Road. Mr. DeMio asked what the objection is for. Mr. Biondillo stated that the previous owner moved out kitchen equipment exposing electrical conductors. The hood system also needs to be brought into compliance.

President Daymut noted the necessity for an executive session for the purpose of discussing legal matters with the Law Director and personnel matters pertaining to a public official. It was so moved by Mr. DeMio and seconded by Mr. Dooner to adjourn from open session into executive session [Article XI, Section 9, City Charter]. All members present voted aye and the motion carried. Council adjourned into executive session at 7:35 p.m. Also present were Law Director Ken Kraus, and Building Commissioner Tony Biondillo. Tony Biondillo left executive session at 7:42 p.m. Ken Kraus left executive session at 7:46 p.m. The executive session concluded at 7:59 p.m. and reconvened in open session.

The recommendation is to suspend and adopt on this item. Finally, Resolution No. 2015-076 is to authorize the Mayor to advertise for bids for a proposed project on the West 130<sup>th</sup> Street pump station. The recommendation is to suspend and adopt on this item. I'll be happy to take any questions.





